by amending section 213 (MCL 18.1213), as amended by 2006 PA 269.

- (a) "Fund" means the motor transport revolving fund created insubsection (4).
- 4 (b) "Motor vehicle" means a passenger vehicle, van, minibus,5 bus, truck, tractor, or other motorized vehicle.
 - (2) The department may issue directives relative to all the following for motor vehicles except for those motor vehicles under the jurisdiction of the state transportation department:
 - (a) The purchasing, leasing, maintaining, operating, replacing, and disposing of motor vehicles for all state agencies.
 - (b) The using of state owned motor vehicles for official

- 18 THE MOTOR VEHICLE HAS BEEN DRIVEN AND HOW MANY MILES THE MOTOR
- 19 VEHICLE HAS BEEN DRIVEN.
