SENATE BILL No. 54

January 28, 2015, Introduced by Senators CASPERSON, PAVLOV, NOFS, ZORN, KNEZEK, MARLEAU, SCHMIDT, HORN, GREEN and BOOHER and referred to the Committee on Outdoor Recreation and Tourism.

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending sections 40104, 40112, and 48703a (MCL 324.40104,
324.40112, and 324.48703a), section 40104 as added by 1995 PA 57,
section 40112 as amended by 1996 PA 316, and section 48703a as
amended by 2014 PA 281.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 40104. (1) "Take" means to hunt with any weapon, dog,
raptor, or other wild or domestic animal trained for that purpose;
kill; chase; follow; harass; harm; pursue; shoot; rob; trap;
capture; or collect animals, or to attempt to engage in such an
THAT activity.

(2) "Transport" means to carry or ship animals within this state or to points outside this state.

- 1 (3) "Trap" means taking or attempting TO TAKE OR ATTEMPT to
- 2 take animals by means of a trap or other device designed to kill or
- 3 capture animals.
- 4 (4) "UNMANNED AERIAL VEHICLE" MEANS AN UNMANNED VEHICLE OR
- 5 DEVICE THAT USES AERODYNAMIC FORCES TO ACHIEVE FLIGHT.
- 6 (5) "UNMANNED SUBMERSIBLE VEHICLE" MEANS AN UNMANNED VEHICLE

- 8 (6) (4) "Vehicle" means every device in, upon, or by which any
- 9 person or property is or may be transported, except devices

- 11 Sec. 40112. (1) A person AN INDIVIDUAL shall not obstruct or
- 12 interfere in the lawful taking of animals by another
- 13 person.INDIVIDUAL.
- 14 (2) A person AN INDIVIDUAL violates this section when the
- 15 person-INDIVIDUAL intentionally or knowingly does any of the
- 16 following:
- 17 (a) Drives or disturbs animals for the purpose of disrupting a
- 18 lawful taking.
- 19 (b) Blocks, impedes, or harasses another person INDIVIDUAL who
- 20 is engaged in the process of lawfully taking an animal.
- 21 (c) Uses a natural or artificial visual, aural, olfactory,
- 22 gustatory, or physical stimulus to affect animal behavior in order
- 23 to hinder or prevent the lawful taking of an animal.
- 24 (d) Erects barriers to deny ingress or egress to areas where
- 25 the lawful taking of animals may occur. This subdivision does not
- 26 apply to a person AN INDIVIDUAL who erects barriers to prevent
- 27 trespassing on his or her property.

- 1 (e) Interjects himself or herself into the line of fire of a 2 person AN INDIVIDUAL lawfully taking wildlife.
- 3 (f) Affects the condition or placement of personal or public
- property intended for use in the lawful taking of an animal in

- (g) Enters or remains upon private lands without the 7
- permission of the owner or the owner's agent, for the purpose of 8

- 10 (H) USES AN UNMANNED AERIAL VEHICLE OR UNMANNED SUBMERSIBLE
- 11 VEHICLE TO INTERFERE WITH OR HARASS ANOTHER INDIVIDUAL WHO IS
- 12 ENGAGED IN THE PROCESS OF LAWFULLY TAKING AN ANIMAL OR FISH.
- (I) (h) Engages in any other act or behavior for the purpose 13
- 14 of violating this section.
- 15 (3) Upon petition of an aggrieved person or a person AN
- INDIVIDUAL who reasonably may be aggrieved by a violation of this 16
- section, a court of competent jurisdiction, upon a showing that a 17
- person AN INDIVIDUAL was engaged in and threatens to continue to 18
- 19 engage in illegal conduct under this section, may enjoin that
- 20 conduct.
- 21 (4) A person AN INDIVIDUAL who violates this section is guilty
- 22 of a misdemeanor , punishable by imprisonment for not more than 93
- days or a fine of not less than \$500.00 or more than \$1,000.00, 23
- 24 or both, and the costs of prosecution. A person-AN INDIVIDUAL who
- violates this section a second or subsequent time is guilty of a 25
- misdemeanor punishable by imprisonment for not more than 1 year -26

- 1 both, and the costs of prosecution. In addition to the penalties
- 2 provided for in this subsection, any permit or license issued by
- 3 the department authorizing the person_INDIVIDUAL to take animals

- 7 (5) This section does not apply to a peace officer while the

- 9 Sec. 48703a. (1) The legislature finds and declares that
- 10 aquatic invasive species, including Asian carp, represent a
- 11 significant threat to the state's fisheries, aquatic resources,
- 12 outdoor recreation and tourism economies, and public safety.
- 13 (2) The natural resources commission has the exclusive
- 14 authority to regulate the taking of fish in this state. SPORT
- 15 FISHING UNDER THIS PART. The natural resources commission shall, to
- 16 the greatest extent practicable, utilize principles of sound
- 17 scientific management in making decisions regarding the taking of
- 18 fish. REGULATION OF SPORT FISHING UNDER THIS PART. The natural
- 19 resources commission may take testimony from department personnel,
- 20 independent experts, and others, and review scientific literature
- 21 and data, among other sources, in support of its THE COMMISSION'S
- 22 duty to use principles of sound scientific management. The natural

- 25 meeting and an opportunity for public input. Not less than 30 days

- 1 (a) Each member of each standing committee of the senate or
- 2 house of representatives that considers legislation pertaining to
- 3 conservation, the environment, natural resources, recreation,
- 4 tourism, or agriculture.
- 5 (b) The chairperson of the senate appropriations committee and
- 6 the chairperson of the house of representatives appropriations
- 7 committee.
- 8 (c) The members of the subcommittee of the senate
- 9 appropriations committee and the subcommittee of the house of
- 10 representatives appropriations committee that consider the budget
- 11 of the department of natural resources.
- 12 (3) (d) For the fiscal year ending September 30, 2015, there
- is appropriated for the department the sum of \$1,000,000.00 to
- 14 implement management practices necessary for rapid response,
- 15 prevention, control, and/or OR elimination of aquatic invasive
- 16 species, including Asian carp. Any portion of the amount under this
- 17 section that is not expended in the fiscal year ending September
- 18 30, 2015 shall not lapse to the general fund but shall be carried
- 19 forward in a work project account that is in compliance with
