A bill to amend 1978 PA 368, entitled
"Public health code,"
by amending sections 20109, 21703, and 21715 (MCL 333.20109,
333.21703, and 333.21715), section 20109 as amended by 1996 PA 224.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 20109. (1) "Nursing home" means a nursing care facility,
- 2 including a county medical care facility, that provides organized
- 3 nursing care and medical treatment to 7 or more unrelated
- 4 individuals suffering or recovering from illness, injury, or
- 5 infirmity. AS USED IN THIS SUBSECTION, "MEDICAL TREATMENT" INCLUDES
- 6 TREATMENT BY AN EMPLOYEE OR INDEPENDENT CONTRACTOR OF THE NURSING
- 7 HOME WHO IS AN INDIVIDUAL LICENSED OR OTHERWISE AUTHORIZED TO
- 8 ENGAGE IN A HEALTH PROFESSION UNDER PART 170 OR 175. Nursing home
- 9 does not include a ANY OF THE FOLLOWING:
 - (A) A unit in a state correctional facility. Nursing home does

- Sec. 21703. (1) "Patient" means a person who receives care or
- 26 services at a nursing home.RESIDENT.
- 27 (2) "Patient's representative" OR "RESIDENT'S REPRESENTATIVE"

- 20 RESIDENT'S clinical record by a licensed or certified health care

- Sec. 21715. (1) A nursing home shall provide:
- 23 (a) A program of planned and continuing nursing care under the
- 24 charge of a registered nurse. in a skilled facility and a licensed
- 25 practical nurse with a registered nurse consultant in an
- 26 intermediate care facility. This subdivision shall expire December
- **27** 31, 1979.

- 1 (b) A program of planned and continuing medical care_TREATMENT
- 2 under the charge of physicians. A NURSING HOME, REGARDLESS OF ITS
- 3 STATUS AS A LEGAL ENTITY, MAY EMPLOY OR CONTRACT WITH AN INDIVIDUAL
- 4 LICENSED OR OTHERWISE AUTHORIZED TO ENGAGE IN A HEALTH PROFESSION
- 5 UNDER PART 170 OR 175 TO PROVIDE THE PROGRAM OF PLANNED AND
- 6 CONTINUING NURSING CARE AND MEDICAL TREATMENT UNDER THIS
- 7 SUBSECTION, WHICH CARE AND TREATMENT INCLUDE DIRECT CLINICAL
- 8 SERVICES TO RESIDENTS.
- 9 (2) Nursing A NURSING HOME SHALL PROVIDE NURSING care and
- 10 medical care shall consist TREATMENT THAT CONSIST of services given
- 11 to individuals RESIDENTS who are subject to prolonged suffering
- 12 from illness or injury or who are recovering from illness or
- 13 injury. The services shall be A NURSING HOME SHALL PROVIDE THE CARE
- 14 AND TREATMENT within the ability of the NURSING home to provide and
- 15 shall include the functions of medical care such as TREATMENT
- 16 INCLUDING THE diagnosis and treatment of an illness; nursing care
- 17 via assessment, planning, and implementation; evaluation of a
- 18 patient's RESIDENT'S health care needs; and the carrying out of
- 19 required treatment prescribed by a physician.
