

SENATE BILL No. 97

February 10, 2015, Introduced by Senator SHIRKEY and referred to the Committee on Appropriations.

A bill to amend 1984 PA 431, entitled
"The management and budget act,"
by amending section 384 (MCL 18.1384), as amended by 1999 PA 8.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 384. (1) A state agency which applies for federal
2 financial assistance **OR ANY OTHER FORM OF FINANCIAL ASSISTANCE**
3 shall notify the department, **THE MAJORITY LEADER OF THE SENATE, THE**
4 **SPEAKER OF THE HOUSE OF REPRESENTATIVES, THE APPROPRIATIONS**
5 **COMMITTEES, AND THE FISCAL AGENCIES** within 10 days after the
6 application is sent. The notification to apply for federal
7 financial assistance **OR ANY OTHER FORM OF FINANCIAL ASSISTANCE**
8 shall be on a form prescribed by, and contain information requested
9 by, the department. Within 10 days after the state agency receives
10 notice that its application for federal financial assistance **OR ANY**

1 **OTHER FORM OF FINANCIAL ASSISTANCE** is awarded, rejected, revised,
2 or deferred, the state agency shall provide notice of the award,
3 rejection, revision, or deferment of the application to the
4 department, **THE MAJORITY LEADER OF THE SENATE, THE SPEAKER OF THE**
5 **HOUSE OF REPRESENTATIVES, THE APPROPRIATIONS COMMITTEES, AND THE**
6 **FISCAL AGENCIES. THE NOTICE SHALL ALSO INCLUDE ALL STIPULATIONS AND**
7 **CONDITIONS ASSOCIATED WITH RECEIVING THE FEDERAL FINANCIAL**
8 **ASSISTANCE OR OTHER FORM OF FINANCIAL ASSISTANCE.**

9 (2) Within 30 days after a state agency receives notice that a
10 federal grant **OR ANY OTHER FORM OF FINANCIAL ASSISTANCE** has been
11 awarded to the state for which organizations or units of local
12 government are eligible to apply, the state agency administering
13 the federal grant program **OR THE OTHER FORM OF FINANCIAL ASSISTANCE**
14 shall report to the legislature, **THE APPROPRIATIONS COMMITTEES,** and
15 the fiscal agencies the availability of the ~~grant~~-funds and the
16 proposed plan for allocating the ~~grant~~-funds to the organizations
17 or units of local government. A state agency shall not commit any
18 federal grant funds **OR FUNDS FROM ANY OTHER SOURCE** before this
19 notification to the legislature has occurred and a subsequent
20 appropriation of the funds is made by the legislature.

21 (3) Before December 1 and June 1 of each year, each principal
22 department shall report to the **MAJORITY LEADER OF THE SENATE, THE**
23 **SPEAKER OF THE HOUSE OF REPRESENTATIVES, THE** appropriations
24 committees, the fiscal agencies, and the department estimates on
25 the extent to which federal revenues **OR ANY OTHER FORM OF FINANCIAL**
26 **ASSISTANCE** appropriated have been realized and are expected for the
27 remainder of the fiscal year. The report shall detail the estimate

- 2 assistance account.
