## **SENATE BILL No. 166**

February 26, 2015, Introduced by Senators CASPERSON, SCHMIDT, KNEZEK, PROOS, ZORN, HANSEN and WARREN and referred to the Committee on Transportation.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 33 (MCL 257.33), as amended by 2013 PA 36, and by adding section 7b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 7B. "COMMERCIAL QUADRICYCLE" MEANS A VEHICLE THAT
- 2 SATISFIES ALL OF THE FOLLOWING:
- 3 (A) THE VEHICLE HAS FULLY OPERATIVE PEDALS FOR PROPULSION 4 ENTIRELY BY HUMAN POWER.
  - (B) THE VEHICLE HAS AT LEAST 4 WHEELS AND IS OPERATED IN A MANNER SIMILAR TO A BICYCLE.
    - (C) THE VEHICLE HAS AT LEAST 6 SEATS FOR PASSENGERS.
- 8 (D) THE VEHICLE IS DESIGNED TO BE OCCUPIED BY A DRIVER AND
- 9 POWERED EITHER BY PASSENGERS PROVIDING PEDAL POWER TO THE DRIVE

- 1 TRAIN OF THE VEHICLE OR BY A MOTOR CAPABLE OF PROPELLING THE

- 3 (E) THE VEHICLE IS USED FOR COMMERCIAL PURPOSES.

- 6 Sec. 33. "Motor vehicle" means every vehicle that is self-
- 7 propelled, but for purposes of chapter 4 of this act motor vehicle
- 8 does not include industrial equipment such as a forklift, a front-
- 9 end loader, or other construction equipment that is not subject to
- 10 registration under this act. Motor vehicle does not include an
- 11 electric patrol vehicle being operated in compliance with the
- 12 electric patrol vehicle act, 1997 PA 55, MCL 257.1571 TO 257.1577.
- 13 Motor vehicle does not include an electric personal assistive
- 14 mobility device. Motor vehicle does not include an electric
- 15 carriage. MOTOR VEHICLE DOES NOT INCLUDE A COMMERCIAL QUADRICYCLE.
- 16 Enacting section 1. This amendatory act does not take effect
- 17 unless Senate Bill No. 165
- of the 98th Legislature is enacted into law.
