## **SENATE BILL No. 445**

September 9, 2015, Introduced by Senators KOWALL, PAVLOV, ROBERTSON, COLBECK, GREEN, JONES and BRANDENBURG and referred to the Committee on Judiciary.

A bill to prohibit local units of government from enacting or enforcing any law, ordinance, policy, or rule that limits local officials, officers, or employees from communicating or cooperating with appropriate federal officials concerning the immigration status of individuals; to prescribe the powers and duties of certain local officers, officials, and employees; to provide for certain reporting requirements; and to prescribe penalties.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act shall be known and may be cited as the "sanctuary policy prohibition act".
  - Sec. 3. As used in this act:
    - (a) "Governing body" means any of the following:

- 5 (b) "Local unit of government" means a county, city, village,

- 7 Sec. 5. The governing body of a local unit of government shall
- 8 not enact or enforce any law, ordinance, policy, or rule that
- 9 limits or prohibits a peace officer or local official, officer, or
- 10 employee from communicating or cooperating with appropriate federal
- 11 officials concerning the immigration status of an individual in
- 12 this state.
- Sec. 7. (1) The governing body of a local unit of government
- 14 shall provide written notice to each peace officer, official,
- 15 officer, and employee in the local unit of government of his or her
- 16 duty to cooperate with appropriate federal and state officials
- 17 concerning the enforcement of federal and state immigration laws.
- 18 (2) The governing body of a local unit of government shall
- 19 provide written confirmation to the Michigan legislature that the
- 20 local unit of government has complied with the requirements of
- 21 subsection (1).
- Sec. 9. A peace officer who has probable cause to believe that
- 23 an individual under arrest is not legally present in the United
- 24 States shall report that individual to the United States
- 25 Immigration and Customs Enforcement office.
- 26 Sec. 11. Before March 1 of each year, the governing body of a
- 27 local unit of government shall report to the Michigan legislature

- 1 the number of reports made to the United States Immigration and
- 2 Customs Enforcement office pursuant to this act.
- 3 Sec. 13. Notwithstanding any other provision of law to the
- 4 contrary, if the governing body of a local unit of government fails
- 5 to comply with 1 or more of the requirements of this act, the state
- 6 treasurer shall withhold the total annual payment amount that the
- 7 local unit of government receives under the Glenn Steil state
- 8 revenue sharing act of 1971, 1971 PA 140, MCL 141.901 to 141.921,
- 9 for each year or portion of a year that the local unit of
- 10 government fails to comply with the requirements of this act.
- 11 Enacting section 1. This act takes effect 90 days after the
- 12 date it is enacted into law.
