

SENATE BILL No. 605

November 4, 2015, Introduced by Senators HERTEL, SMITH, GREGORY, HUNE and HOOD and referred to the Committee on Appropriations.

A bill to make, supplement, and adjust appropriations for the department of health and human services for the fiscal year ending September 30, 2016; and to provide for the expenditure of the appropriations.

16 PROVISIONS CONCERNING APPROPRIATIONS

17 **GENERAL SECTIONS**

18 Sec. 201. In accordance with the provisions of section 30 of
 19 article IX of the state constitution of 1963, total state spending
 20 from state resources in this appropriation act for the fiscal year
 21 ending September 30, 2016 is \$2,112,200.00 and state appropriations
 22 paid to local units of government are \$0.

23 Sec. 202. The appropriations authorized under this act are
 24 subject to the management and budget act, 1984 PA 431, MCL 18.1101
 25 to 18.1594.

1 DEPARTMENT OF HEALTH AND HUMAN SERVICES

2 Sec. 301. It is the intent of the legislature that the W.J.
3 Maxey training school serve juveniles who may otherwise fall under
4 the jurisdiction of the department of corrections if not served at
5 a state-operated juvenile facility.

6 Sec. 302. It is the intent of the legislature that the W.J.
7 Maxey training school operate as a secure facility for juveniles
8 with an on-site medical staff for juveniles with mental health
9 needs who pose a security risk and, therefore, cannot be served
10 under the standards set up under the department of health and human
11 services for privately operated facilities.
