

SENATE BILL No. 705

January 14, 2016, Introduced by Senator CASPERSON and referred to the Committee on Health Policy.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16d of chapter XVII (MCL 777.16d), as amended
by 2012 PA 365.
