- 3 SURGICAL POLICY OR CERTIFICATE THAT PROVIDES COVERAGE FOR ANY OTHER
- 4 PROSTHESIS AND A HEALTH MAINTENANCE ORGANIZATION THAT ISSUES OR
- 5 RENEWS A GROUP OR INDIVIDUAL CONTRACT THAT PROVIDES COVERAGE FOR
- 6 ANY OTHER PROSTHESIS SHALL INCLUDE IN THAT POLICY, CERTIFICATE, OR
 - CONTRACT COVERAGE FOR SCALP HAIR PROSTHESIS FOR A COVERED
