## **SENATE BILL No. 943**

May 3, 2016, Introduced by Senators HORN, JONES, ZORN, GREGORY, SHIRKEY, COLBECK, PROOS, EMMONS, ROCCA, BRANDENBURG, KNOLLENBERG, MACGREGOR, GREEN, BOOHER, NOFS and SCHMIDT and referred to the Committee on Michigan Competitiveness.

A bill to amend 1953 PA 232, entitled "Corrections code of 1953,"

(MCL 791.201 to 791.285) by adding section 84.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 84. (1) ON A QUARTERLY BASIS, EACH FIELD OPERATIONS
- 2 ADMINISTRATION REGION SHALL PROVIDE TO THE DEPARTMENT OF HEALTH AND
- 3 HUMAN SERVICES A LIST OF SUPERVISED INDIVIDUALS WITHIN THAT REGION
- 4 WHO HAVE ABSCONDED FROM SUPERVISION.
  - (2) AS USED IN THIS SECTION:
- 6 (A) "ABSCOND" MEANS THAT AN INDIVIDUAL SUPERVISED UNDER THIS
- 7 ACT INTENTIONALLY FAILS TO REPORT TO HIS OR HER SUPERVISING AGENT
- 8 AND INTENTIONALLY FAILS TO ADVISE HIS OR HER SUPERVISING AGENT OF
- 9 HIS OR HER WHEREABOUTS.
- 10 (B) "FIELD OPERATIONS ADMINISTRATION REGION" MEANS 1 OF THE
- 11 GEOGRAPHIC REGIONS DELINEATED BY THE DEPARTMENT THAT ARE CHARGED

- 1 WITH THE RESPONSIBILITY OF OVERSEEING SUPERVISED INDIVIDUALS WITHIN
