June 7, 2016, Introduced by Senators O'BRIEN, WARREN, BIEDA, GREGORY, KNEZEK, ROCCA, SCHUITMAKER, NOFS, ANANICH, HOOD, EMMONS, KOWALL and BRANDENBURG and referred to the Committee on Regulatory Reform.

A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 18255 to part 182A.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

PART 182A

2	APPLIED BEHAVIOR ANALYSIS
3	SEC. 18255. (1) THE MICHIGAN BOARD OF BEHAVIOR ANALYSTS IS
4	CREATED IN THE DEPARTMENT AND CONSISTS OF THE FOLLOWING 9 VOTING
5	MEMBERS:

(A) FIVE BEHAVIOR ANALYSTS. THE 5 MEMBERS APPOINTED UNDER THIS SUBDIVISION SHALL BE BEHAVIOR ANALYSTS WHO ARE LICENSED UNDER THIS PART, EXCEPT THAT THE FIRST 5 MEMBERS APPOINTED TO THE BOARD UNDER THIS SUBDIVISION MAY BE BOARD-CERTIFIED BEHAVIOR ANALYSTS WHO ARE NOT LICENSED UNDER THIS PART. MEMBERS DESCRIBED IN THIS SUBDIVISION

- 1 SHALL BE APPOINTED IN A MANNER THAT ENSURES THAT 4 OF THE MEMBERS
- 2 SERVING ON THE BOARD ARE ENGAGED IN PROVIDING CLINICAL SERVICES AND
- 3 1 IS ENGAGED IN PROVIDING APPLIED BEHAVIOR ANALYSIS SERVICES TO THE
- 4 MEDICAID POPULATION IN ADDITION TO PROVIDING CLINICAL SERVICES. AS
- 5 USED IN THIS SUBDIVISION:
- 6 (i) "MEDICAID" MEANS THAT TERM AS DEFINED IN SECTION 2701.
- 7 (ii) "MEDICAID POPULATION" MEANS THOSE INDIVIDUALS WHO RESIDE
- 8 IN THIS STATE AND WHO ARE ELIGIBLE FOR MEDICAID.
- 9 (B) ONE INDIVIDUAL WHO IS AFFILIATED WITH A UNIVERSITY IN THIS
- 10 STATE AND PROVIDES INSTRUCTION OR CONDUCTS RESEARCH IN APPLIED
- 11 BEHAVIOR ANALYSIS.
- 12 (C) ONE ASSISTANT BEHAVIOR ANALYST.
- 13 (D) ONE PHYSICIAN WHO IS LICENSED UNDER PART 170 OR 175 AND
- 14 WORKS WITH PATIENTS WITH AUTISM SPECTRUM DISORDERS OR BRAIN
- 15 INJURIES.
- 16 (E) ONE PUBLIC MEMBER.
- 17 (2) THE TERMS OF OFFICE OF INDIVIDUAL MEMBERS OF THE BOARD,
- 18 EXCEPT THOSE APPOINTED TO FILL VACANCIES, EXPIRE 4 YEARS AFTER THE
- 19 APPOINTMENT ON DECEMBER 31 OF THE YEAR IN WHICH THE TERM EXPIRES.
- 20 HOWEVER, FOR THE MEMBERS FIRST APPOINTED TO THE BOARD UNDER
- 21 SUBSECTION (1), 3 MUST SERVE FOR 2 YEARS, 3 MUST SERVE FOR 3 YEARS,
- 22 AND 3 MUST SERVE FOR 4 YEARS.
- 23 Enacting section 1. This amendatory act takes effect 90 days
- 24 after the date it is enacted into law.
- 25 Enacting section 2. This amendatory act does not take effect
- 26 unless Senate Bill No. 1015
- of the 98th Legislature is enacted into law.
