THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 34. (1) Except as provided in this section and section 36, an individual required to be registered under article II shall not do 1 or more of the following:
- 4 (a) Work within a student safety zone.

- (b) Loiter within a student safety zone.
- (C) WORK AT OR VOLUNTEER FOR AN ORGANIZATION THAT WORKS WITH INDIVIDUALS WHO ARE LESS THAN 18 YEARS OF AGE OR VICTIMS OF SEXUAL ASSAULT.
- (2) An individual who violates this section is guilty of a crime as follows:
 - (a) For the first violation, the individual is guilty of a

- 1 misdemeanor punishable by imprisonment for not more than 1 year or
- 2 a fine of not more than \$1,000.00, or both.
- 3 (b) An individual who violates this section and has 1 or more
- 4 prior convictions under this section is guilty of a felony
- 5 punishable by imprisonment for not more than 2 years or a fine of
- 6 not more than \$2,000.00, or both.
- 7 (3) Subsection (1)(a) does not apply to any of the following:
- 8 (a) An individual who was working within a student safety zone
- 9 on January 1, 2006. However, this exception does not apply to an
- 10 individual who initiates or maintains contact with a minor within
- 11 that student safety zone.
- 12 (b) An individual whose place of employment is within a
- 13 student safety zone solely because a school is relocated or is
- 14 initially established 1,000 feet or less from the individual's

- 17 that student safety zone.
- 18 (c) An individual who only intermittently or sporadically
- 19 enters a student safety zone for the purpose of work. However, this
- 20 exception does not apply to an individual who initiates or
- 21 maintains contact with a minor within a student safety zone.
- 22 (4) This section does not prohibit an individual from being
- 23 charged with, convicted of, or punished for any other violation of
- 24 law that is committed by that individual while violating this
- 25 section.
- 26 (5) Nothing in this section shall be construed to prohibit an
- 27 individual from exercising his or her right to vote.
