SENATE BILL No. 1071

September 8, 2016, Introduced by Senators GREEN, JONES and ZORN and referred to the Committee on Outdoor Recreation and Tourism.

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending section 40113a (MCL 324.40113a), as amended by 2014 PA
281, and by adding sections 43528d and 48714b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 40113a. (1) The legislature finds and declares that:

- (a) The fish and wildlife populations of the state and their habitat are of paramount importance to the citizens of this state.
- (b) The conservation of fish and wildlife populations of the state depend upon the wise use and sound scientific management of the state's natural resources.
- (c) The sound scientific management of the fish and wildlife populations of the state, including hunting of bear, is declared to

- 1 be in the public interest.
- 2 (d) The sound scientific management of bear populations in
- 3 this state is necessary to minimize human/bear encounters and to
- 4 prevent bears from threatening or harming humans, livestock, and
- 5 pets.
- **6** (2) The natural resources commission has the exclusive
- 7 authority to regulate the taking of game as defined in section
- 8 40103 in this state, INCLUDING, BUT NOT LIMITED TO, REGULATING THE
- 9 USE OF COMMERCIAL GUIDES IN TAKING GAME. The natural resources
- 10 commission shall, to the greatest extent practicable, utilize
- 11 principles of sound scientific management in making decisions
- 12 regarding the taking of game. The natural resources commission may
- 13 take testimony from department personnel, independent experts, and
- 14 others, and review scientific literature and data, among other
- 15 sources, in support of its duty to use principles of sound
- 16 scientific management. Issuance of orders by the natural resources
- 17 THE commission SHALL ISSUE ORDERS regarding the taking of game
- 18 shall be made following a public meeting and an opportunity for
- 19 public input. Not less than 30 days before issuing an order, the
- 20 natural resources commission shall provide a copy of the order to
- 21 each of the following:
- 22 (a) Each member of each standing committee of the senate or
- 23 house of representatives that considers legislation pertaining to
- 24 conservation, the environment, natural resources, recreation,
- 25 tourism, or agriculture.

- 27 the chairperson of the house of representatives appropriations

- 2 (c) The members of the subcommittee of the senate

- 6 (3) The legislature declares that hunting, fishing, and the
- 7 taking of game are a valued part of the cultural heritage of this
- 8 state and should be forever preserved. The legislature further
- 9 declares that these activities play an important part in the
- 10 state's economy and in the conservation, preservation, and
- 11 management of the state's natural resources. Therefore, the
- 12 legislature declares that the citizens of this state have a right
- 13 to hunt, fish, and take game, subject to the regulations and
- 14 restrictions prescribed by subsection (2) and law.
