

SENATE BILL No. 1081

September 20, 2016, Introduced by Senators JONES, O'BRIEN and SCHUITMAKER and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled

"The code of criminal procedure,"

by amending section 16t of chapter XVII (MCL 777.16t), as amended by 2013 PA 216.
