Cities and Villages Includes \$38.1 million, representing 21.8% of \$175.0 million – 21.8% is the share of Michigan Transportation Fund (MTF) revenue reserved for distribution to cities and villages in Section 10 of Public Act 51 of 1951 (Act 51). FY 2017-18 Supplemental Boilerplate Items

DEPARTMENT OF TRANSPORTATION

Sec. 301. Distribution to Cities and Villages

Directs that the \$38.1 million appropriation to cities and villages be distributed among cities and villages according to the provisions of Section 13 of Act 51; limits use to construction or preservation of city/village streets.

Sec. 302. Distribution to County Road Commissions

Directs that the \$68.4 million appropriation to county road commissions be distributed among county road commissions according to the provisions of Section 12 of Act 51; limits use to construction or preservation of county roads. Defines "county road commission" by reference to definition in Section 10c of Act 51. [The definition includes those counties where the county board of commissioners or county administrator has assumed the functions of the county road commission.]

Sec. 303. Distribution for State Trunkline Preservation, Next Generation Technologies, Service Delivery

Prescribes authorized uses of the \$68.4 million appropriation: Requires not less than \$53.4 million be used for state trunkline preservation in accordance with Section 11 of Act 51; authorizes of up to \$15.0 million for projects related to next generation technologies, hydrogen fueling stations, and service delivery including demonstration projects related to enhanced transportation services for senior citizens and persons with disabilities.
