- 19 by project. The report shall be submitted on or before March 1,
- 20 2019. Funds appropriated in part 1 shall not be used by a
- 21 governmental entity to purchase, construct, operate, or maintain a
- 22 communications network to provide service to any residential or
- 23 commercial premises. This prohibition does not apply to state
- 24 expenditures for a transportation purpose, connected vehicle
- 25 communication technologies, or other transportation related
- 26 activities.
