SUBSTITUTE FOR

HOUSE BILL NO. 5017

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 411x.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 411X. (1) A PERSON SHALL NOT CYBERBULLY ANOTHER PERSON.
- 2 (2) A PERSON WHO VIOLATES SUBSECTION (1) IS GUILTY OF A
- 3 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 93 DAYS OR
- 4 A FINE OF NOT MORE THAN \$500.00, OR BOTH.
- 5 (3) A PERSON WHO VIOLATES SUBSECTION (1), AND WHO HAS A PRIOR
- 6 CONVICTION FOR A VIOLATION OF SUBSECTION (1), IS GUILTY OF A
- 7 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1 YEAR OR
- 8 A FINE OF NOT MORE THAN \$1,000.00, OR BOTH.
- 9 (4) A PERSON WHO VIOLATES SUBSECTION (1) IN A MANNER THAT
- 10 INVOLVES A CONTINUED PATTERN OF HARASSING OR INTIMIDATING BEHAVIOR

- 1 AND BY THAT VIOLATION CAUSES SERIOUS INJURY TO THE VICTIM IS GUILTY
- 2 OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 5 YEARS OR
- 3 A FINE OF NOT MORE THAN \$5,000.00, OR BOTH. AS USED IN THIS
- 4 SUBSECTION, "SERIOUS INJURY" MEANS PERMANENT, SERIOUS
- 5 DISFIGUREMENT, SERIOUS IMPAIRMENT OF HEALTH, OR SERIOUS IMPAIRMENT
- 6 OF A BODILY FUNCTION OF A PERSON.
- 7 (5) A PERSON WHO VIOLATES SUBSECTION (1) IN A MANNER THAT
- 8 INVOLVES A CONTINUED PATTERN OF HARASSING OR INTIMIDATING BEHAVIOR
- 9 AND BY THAT VIOLATION CAUSES THE DEATH OF THE VICTIM IS GUILTY OF A
- 10 FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 10 YEARS OR A
- 11 FINE OF NOT MORE THAN \$10,000.00, OR BOTH.
- 12 (6) AS USED IN THIS SECTION:
- 13 (A) "CYBERBULLY" INCLUDES POSTING A MESSAGE OR STATEMENT IN A
- 14 PUBLIC MEDIA FORUM ABOUT ANY OTHER PERSON IF BOTH OF THE FOLLOWING
- 15 APPLY:
- 16 (i) THE MESSAGE OR STATEMENT IS INTENDED TO PLACE A PERSON IN
- 17 FEAR OF BODILY HARM OR DEATH AND EXPRESSES AN INTENT TO COMMIT
- 18 VIOLENCE AGAINST THE PERSON.
- 19 (ii) THE MESSAGE OR STATEMENT IS POSTED WITH THE INTENT TO
- 20 COMMUNICATE A THREAT OR WITH KNOWLEDGE THAT IT WILL BE VIEWED AS A
- 21 THREAT.
- 22 (B) "PATTERN OF HARASSING OR INTIMIDATING BEHAVIOR" MEANS A
- 23 SERIES OF 2 OR MORE SEPARATE NONCONTINUOUS ACTS OF HARASSING OR
- 24 INTIMIDATING BEHAVIOR.
- 25 (C) "PUBLIC MEDIA FORUM" MEANS THE INTERNET OR ANY OTHER
- 26 MEDIUM DESIGNED OR INTENDED TO BE USED TO CONVEY INFORMATION TO
- 27 OTHER INDIVIDUALS, REGARDLESS OF WHETHER A MEMBERSHIP OR PASSWORD

- IS REQUIRED TO VIEW THE INFORMATION. 1
- Enacting section 1. This amendatory act takes effect 90 days 2
- 3 after the date it is enacted into law.
