SUBSTITUTE FOR

HOUSE BILL NO. 5768

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998,"

(MCL 436.1101 to 436.2303) by adding section 204.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 204. (1) EXCEPT FOR AN INDIVIDUAL WHO BRINGS, TRANSPORTS,
- 2 SHIPS, OR IMPORTS ALCOHOLIC LIQUOR INTO THIS STATE UNDER SECTION
- 3 203(8) OR (9), AS APPLICABLE, FOR A RETAILER, OR FOR SACRAMENTAL
- 4 WINES IMPORTED UNDER SECTION 301, A PERSON SHALL NOT SELL, DELIVER,
- 5 OR IMPORT BEER, WINE, OR MIXED SPIRIT DRINK IN THIS STATE UNLESS
- 6 THE PERSON IS 1 OF THE FOLLOWING:
- 7 (A) A SUPPLIER AS THAT TERM IS DEFINED IN SECTION 603.
- 8 (B) A LICENSED DIRECT SHIPPER DESCRIBED IN SECTION 203(10).
- 9 (C) A WHOLESALER.
- 10 (2) EXCEPT FOR AN INDIVIDUAL WHO BRINGS, TRANSPORTS, SHIPS, OR

- 1 IMPORTS ALCOHOLIC LIQUOR INTO THIS STATE UNDER SECTION 203(8) OR
- 2 (9), AS APPLICABLE, FOR A RETAILER, OR FOR SACRAMENTAL WINES
- 3 IMPORTED UNDER SECTION 301, A PERSON DESCRIBED IN SUBSECTION (1)
- 4 MAY ONLY SELL, DELIVER, OR IMPORT BEER, WINE, OR MIXED SPIRIT DRINK
- 5 IN THIS STATE IN 1 OF THE FOLLOWING WAYS:
- 6 (A) A LICENSED DIRECT SHIPPER MAY SELL TO A CONSUMER UNDER
- 7 SECTION 203.
- 8 (B) AN OUTSTATE SELLER OF BEER, OUTSTATE SELLER OF WINE, OR
- 9 OUTSTATE SELLER OF MIXED SPIRIT DRINK, MAY DELIVER THE BEER, WINE,
- 10 OR MIXED SPIRIT DRINK TO THE LICENSED PREMISES OF THE WHOLESALERS
- 11 DESIGNATED TO SELL AND DELIVER THE BEER, WINE, OR MIXED SPIRIT
- 12 DRINK TO THE INDIVIDUAL LICENSED LOCATION OF THE RETAILER IN THE
- 13 WHOLESALER'S SALES TERRITORY UNDER SECTION 305 OR 403, AS
- 14 APPLICABLE.
- 15 (C) A WHOLESALER THAT PICKS UP THE BEER, WINE, OR MIXED SPIRIT
- 16 DRINK FROM THE PREMISES OF AN OUTSTATE SELLER OF BEER, OUTSTATE
- 17 SELLER OF WINE, OR OUTSTATE SELLER OF MIXED SPIRIT DRINK, MAY
- 18 DELIVER THE BEER, WINE, OR MIXED SPIRIT DRINK TO THE LICENSED
- 19 PREMISES OF THE WHOLESALER DESIGNATED TO SELL AND DELIVER THE BEER,
- 20 WINE, OR MIXED SPIRIT DRINK TO THE INDIVIDUAL LICENSED LOCATION OF
- 21 THE RETAILER IN THE WHOLESALER'S SALES TERRITORY UNDER SECTION 305
- 22 OR 403, AS APPLICABLE.
- 23 (D) AN OUTSTATE SELLER OF BEER, OUTSTATE SELLER OF WINE, OR
- 24 OUTSTATE SELLER OF MIXED SPIRIT DRINK MAY DELIVER THE BEER, WINE,
- 25 OR MIXED SPIRIT DRINK TO ITS LICENSED PREMISES IN THIS STATE.
- 26 HOWEVER, THE BEER, WINE, OR MIXED SPIRIT DRINK MUST BE DELIVERED TO
- 27 THE LICENSED PREMISES OF THE WHOLESALER DESIGNATED TO SELL AND

- 1 DELIVER THE BEER, WINE, OR MIXED SPIRIT DRINK TO THE INDIVIDUAL
- 2 LICENSED LOCATION OF THE RETAILER IN THE WHOLESALER'S SALES
- 3 TERRITORY UNDER SECTION 305 OR 403, AS APPLICABLE.
- 4 (E) A BREWER, WINE MAKER, OR MIXED SPIRIT DRINK MANUFACTURER
- 5 THAT HAS A MANUFACTURING PLANT LOCATED OUTSIDE OF THIS STATE MAY
- 6 DELIVER THE BEER, WINE, OR MIXED SPIRIT DRINK MANUFACTURED IN THE
- 7 MANUFACTURING PLANT TO ITS LICENSED PREMISES IN THIS STATE.
- 8 HOWEVER, THE BEER, WINE, OR MIXED SPIRIT DRINK MUST BE DELIVERED TO
- 9 THE LICENSED PREMISES OF THE WHOLESALER DESIGNATED TO SELL AND
- 10 DELIVER THE BEER, WINE, OR MIXED SPIRIT DRINK TO THE INDIVIDUAL
- 11 LICENSED LOCATION OF THE RETAILER IN THE WHOLESALER'S SALES
- 12 TERRITORY UNDER SECTION 305 OR 403, AS APPLICABLE.
- 13 (F) EXCEPT AS OTHERWISE PROVIDED IN THIS ACT, A BREWER, WINE
- 14 MAKER, OR MIXED SPIRIT DRINK MANUFACTURER MAY DELIVER THE BEER,
- 15 WINE, OR MIXED SPIRIT DRINK TO THE LICENSED PREMISES OF THE
- 16 WHOLESALER DESIGNATED TO SELL AND DELIVER THE BEER, WINE, OR MIXED
- 17 SPIRIT DRINK TO THE INDIVIDUAL LICENSED LOCATION OF THE RETAILER IN
- 18 THE WHOLESALER'S SALES TERRITORY UNDER SECTION 305 OR 403, AS
- 19 APPLICABLE.
- 20 (3) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION (4), BOTH OF
- 21 THE FOLLOWING APPLY TO BEER, WINE, OR MIXED SPIRIT DRINK THAT IS
- 22 DELIVERED TO A WHOLESALER UNDER THIS ACT:
- 23 (A) THE WHOLESALER SHALL MAINTAIN THE BEER, WINE, OR MIXED
- 24 SPIRIT DRINK ON THE WHOLESALER'S LICENSED PREMISES.
- 25 (B) THE WHOLESALER SHALL MAKE THE BEER, WINE, OR MIXED SPIRIT
- 26 DRINK MAINTAINED ON THE WHOLESALER'S LICENSED PREMISES AS REQUIRED
- 27 UNDER SUBDIVISION (A) AVAILABLE FOR INSPECTION BY THE COMMISSION

- 1 FOR AT LEAST 24 HOURS BEFORE THE WHOLESALER DELIVERS THE BEER,
- 2 WINE, OR MIXED SPIRIT DRINK TO A RETAILER.
- 3 (4) FOR BEER, WINE, OR MIXED SPIRIT DRINK THAT HAS BEEN
- 4 DELIVERED TO A WHOLESALER UNDER THIS ACT, SUBSECTION (3) DOES NOT
- 5 APPLY AND THE WHOLESALER MAY DELIVER BEER, WINE, OR MIXED SPIRIT
- 6 DRINK TO A RETAILER IF ALL OF THE FOLLOWING APPLY:
- 7 (A) EITHER OF THE FOLLOWING APPLIES:
- 8 (i) THE WHOLESALER CANNOT FULFILL THE RETAILER'S ORDER FOR THE
- 9 BEER, WINE, OR MIXED SPIRIT DRINK FROM THE INVENTORY CURRENTLY
- 10 AVAILABLE ON THE WHOLESALER'S LICENSED PREMISES.
- 11 (ii) THE WHOLESALER INTENDS TO DELIVER THE BEER, WINE, OR
- 12 MIXED SPIRIT DRINK TO A SPECIAL LICENSEE, INCLUDING AS PROVIDED
- 13 UNDER SECTION 526, BEFORE THE 24-HOUR PERIOD UNDER SUBSECTION
- 14 (3) (B) HAS EXPIRED.
- 15 (B) EITHER OF THE FOLLOWING APPLIES:
- 16 (i) THE BEER, WINE, OR MIXED SPIRIT DRINK HAS BEEN DELIVERED
- 17 TO THE ADDRESS OF THE WHOLESALER'S LICENSED PREMISES.
- 18 (ii) THE WHOLESALER PICKED UP THE BEER, WINE, OR MIXED SPIRIT
- 19 DRINK FROM THE LICENSED PREMISES OF ANY OF THE FOLLOWING:
- 20 (A) A BREWER.
- 21 (B) A WINE MAKER.
- 22 (C) A MIXED SPIRIT MANUFACTURER.
- 23 (D) AN OUTSTATE SELLER OF BEER.
- 24 (E) AN OUTSTATE SELLER OF WINE.
- 25 (F) AN OUTSTATE SELLER OF MIXED SPIRIT DRINK.
- 26 (G) A WHOLESALER.
- 27 (C) THE WHOLESALER MAINTAINS THE INVOICE OF THE DELIVERY AND

- ATTACHES DOCUMENTATION TO THE INVOICE THAT DETAILS EACH PRODUCT AND 1
- 2 THE AMOUNT OF EACH PRODUCT THAT WAS NOT PLACED ON THE WHOLESALER'S
- 3 FLOOR.
- 4 (5) THIS SECTION DOES NOT PROHIBIT A BREWER, MICRO BREWER,
- WINE MAKER, SMALL WINE MAKER, OR RETAILER FROM SELLING ALCOHOLIC 5
- LIQUOR OR NONALCOHOLIC BEVERAGES AS PROVIDED IN THIS ACT.
