

## **HOUSE BILL No. 5837**

April 19, 2018, Introduced by Rep. Miller and referred to the Committee on Energy Policy.

A bill to amend 1976 PA 448, entitled "Michigan energy employment act of 1976,"

(MCL 460.801 to 460.848) by adding section 36a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 36A. (1) A MUNICIPAL UNIT OR OTHER POLITICAL SUBDIVISION
- 2 OF ANOTHER STATE OR CANADIAN PROVINCE OWNING A SYSTEM FOR THE
- 3 GENERATION, TRANSMISSION, OR DISTRIBUTION OF ELECTRIC POWER AND
- 4 ENERGY FOR PUBLIC OR PRIVATE USE OR PROPOSING TO OWN SUCH A SYSTEM
- 5 MAY BECOME A MEMBER OR AN ASSOCIATE MEMBER OF, AND MAY WITHDRAW
- 6 FROM, A JOINT AGENCY IN THE SAME MANNER AS A MUNICIPALITY UNDER
- 7 SECTIONS 34(6) AND 36. HOWEVER, IN ADDITION TO COMPLYING WITH THE
- 8 REQUIREMENTS SET FORTH IN SECTIONS 34(6) AND 36, THE MUNICIPAL UNIT

- 1 OR POLITICAL SUBDIVISION OF ANOTHER STATE OR CANADIAN PROVINCE
- 2 SHALL PROVIDE TO THE JOINT AGENCY AN OPINION ACCEPTABLE TO THE
- 3 JOINT AGENCY FROM AN INDIVIDUAL LICENSED TO PRACTICE LAW IN THAT
- 4 STATE OR PROVINCE ATTESTING TO THE FOLLOWING:
- 5 (A) THAT THE LAWS APPLICABLE TO THE PROSPECTIVE MEMBER OR
- 6 ASSOCIATE MEMBER DO NOT PRECLUDE THE PROSPECTIVE MEMBER OR
- 7 ASSOCIATE MEMBER FROM JOINING THE JOINT AGENCY.
- 8 (B) THAT THE PROSPECTIVE MEMBER OR ASSOCIATE MEMBER HAS THE
- 9 LEGAL AUTHORITY UNDER LAWS APPLICABLE TO THE PROSPECTIVE MEMBER OR
- 10 ASSOCIATE MEMBER TO ENTER INTO VALID, BINDING, AND ENFORCEABLE
- 11 AGREEMENTS WITH THE JOINT AGENCY AND MEMBERS AND ASSOCIATE MEMBERS
- 12 OF THE JOINT AGENCY.
- 13 (2) EXCEPT AS OTHERWISE PROVIDED BY THE BOARD OF COMMISSIONERS
- 14 OF THE JOINT AGENCY, A MEMBER OR AN ASSOCIATE MEMBER LOCATED IN
- 15 ANOTHER STATE OR CANADIAN PROVINCE HAS THE SAME RIGHTS, PRIVILEGES,
- 16 AND OBLIGATIONS AS OTHER MEMBERS OR ASSOCIATE MEMBERS OF THE JOINT
- 17 AGENCY.
