THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 74101. As used in this part:
- 2 (a) "Commercial motor vehicle" means a commercial vehicle as
- 3 defined in section 7 of the Michigan vehicle code, 1949 PA 300, MCL
- **4** 257.7.
- 5 (B) "ENDOWMENT FUND" MEANS THE MICHIGAN STATE PARKS ENDOWMENT
- 6 FUND ESTABLISHED IN SECTION 35A OF ARTICLE IX OF THE STATE
- 7 CONSTITUTION OF 1963 AND PROVIDED FOR IN SECTION 74119.
- 8 (C) (b) "Improvement program" means the construction,
- 9 reconstruction, development, improvement, bettering, operating,

- 1 maintaining, and extending a facility at a state park, including a
- 2 site improvement, impoundment, road and parking lot, toilet
- 3 building, concession building, shelter building, bathhouse,
- 4 utility, outdoor center, visitor service facility, ski area, ski
- 5 tow, ski shelter, and administration unit.
- 6 (D) (c)—"Motor vehicle" means a vehicle that is self-
- 7 propelled.
- **8 (E)** "Nonresident motor vehicle" means a motor vehicle
- 9 other than a commercial motor vehicle that is not registered as a
- 10 motor vehicle in this state.
- 11 (F) (e)—"Recreation passport fee" means that term as defined
- 12 in section 2001.
- 13 (G) (f) "Resident motor vehicle" means a motor vehicle other
- 14 than a commercial motor vehicle that is registered as a motor
- 15 vehicle in this state.
- 16 (H) (g) "State park" means a state park or state recreation
- 17 area designated by the director.
- 18 (I) (h)—"State park improvement account" means the state park
- 19 improvement account of the Michigan conservation and recreation
- 20 legacy fund provided for in section 2030.
- 21 (J) (i) "State park revenues" means all revenues collected for
- 22 state parks, including but not limited to, revenue from recreation
- 23 passport fees, motor vehicle permits, concession fees, nonmotorized
- 24 trail permits, fees, leases, camping fees, sale of farm animals
- 25 from Maybury state park, donations, and gifts.
