 - (a) A crime, an element of which is gross negligence, for which the defendant is convicted.
 - (b) A crime, involving AN ELEMENT OF WHICH IS the use of alcohol or a controlled substance, for which the defendant is convicted and that is a violation of 1 or more of the following:
 - (i) Section 14 CONDUCT THAT VIOLATED FORMER SECTION 14 of the explosives act of 1970, Act No. 202 of the Public Acts of 1970,
