THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 136. (1) A PERSON SHALL NOT KNOWINGLY CIRCUMCISE, EXCISE,
- 2 OR INFIBULATE THE WHOLE OR ANY PART OF THE LABIA MAJORA OR LABIA
- 3 MINORA OR CLITORIS OF ANOTHER PERSON WHO IS LESS THAN 18 YEARS OF 4 AGE.
 - (2) A SURGICAL OPERATION IS NOT A VIOLATION OF THIS SECTION IF
 THE OPERATION IS EITHER OF THE FOLLOWING:
 - (A) NECESSARY TO THE HEALTH OF THE PERSON ON WHOM IT IS

- 14 (6) A VIOLATION OF THIS SECTION BY A PERSON LICENSED UNDER THE
- 15 PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.1101 TO 333.25211, IS
- 16 GROUNDS FOR PERMANENT REVOCATION OF THAT LICENSE.
- 17 (7) THIS SECTION DOES NOT PROHIBIT A PERSON FROM BEING CHARGED
- 18 WITH, CONVICTED OF, OR PUNISHED FOR ANY OTHER VIOLATION OF LAW
- 19 ARISING OUT OF THE SAME TRANSACTION AS THE VIOLATION OF THIS
- 20 SECTION.
- 21 Enacting section 1. This amendatory act takes effect 90 days
- 22 after the date it is enacted into law.
