

**SUBSTITUTE FOR
HOUSE BILL NO. 5001**

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"
by amending sections 50507, 50703, 50706, and 51101 (MCL 324.50507,
324.50703, 324.50706, and 324.51101), section 50507 as amended by
2016 PA 248, sections 50703 and 50706 as added by 1995 PA 57, and
section 51101 as amended by 2006 PA 383, and by adding part 535;
and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 50507. (1) The authority shall finance only forest
2 management operations and practices consistent with part 525 that
3 follow the guidelines, rules, and objectives prescribed and
4 approved by the department as these guidelines, rules, and
5 objectives are amended by the department.

6 (2) Funds managed by the authority shall be applied in a

1 manner consistent with part 525 and the land management planning
2 policies of the department on lands that have been identified for
3 forest management practices. In the absence of an approved state
4 forest management plan covering a candidate area, an interim
5 procedure, as adopted by the department, shall be used to ensure
6 that all forest values have been considered in selecting sites for
7 investment with funds of the authority. The department shall
8 annually submit a list of activities and practices allocated from
9 the funds generated under this part for the board's review and
10 determination of consistency with this part.

11 (3) The executive director of the authority shall notify the
12 department if the authority projects a probable default on any
13 bonds or notes issued by the authority. Within 1 year of receipt of
14 the notification, or within less than 1 year, if the notification
15 indicates a shorter time period is necessary to avoid a default,
16 the department shall identify and convey to the authority
17 sufficient timber on tax reverted lands to enable the authority to
18 avoid the projected default and to provide for timely payment of
19 principal of and interest on the authority's bonds or notes. The
20 authority may only issue contracts for the cutting and sale of
21 timber that has been conveyed to the authority under this section
22 to avoid a default on any bonds or notes issued by the authority.
23 The determination of the board as to the need to cut and sell
24 timber is conclusive. Contracts for the cutting and sale of timber
25 shall be consistent with part 525 and with the guidelines, rules,
26 and objectives prescribed by the department.

27 (4) The authority shall establish a fund designated as the

1 "forest development fund". ~~Any~~ **REVENUE AS PROVIDED UNDER SECTION**
 2 **53519 AND ANY** money on hand or received in the future from bond
 3 proceeds and from contracts for the cutting and sale of timber on
 4 tax reverted lands shall be deposited in the forest development
 5 fund. In addition, this fund may receive revenues from any other
 6 source. ~~Except as otherwise provided in subsection (6), the~~ **THE**
 7 authority shall use money in the forest development fund for 1 or
 8 more of the following:

9 (a) To provide for the payment of principal of and interest on
 10 any bonds or notes issued by the authority.

11 (b) For reforestation, forest protection, and timber stand
 12 improvement.

13 (c) To obtain and maintain certification of sustainable
 14 forestry standards in the state forest under section 52505.

15 **(D) FOR THE ADMINISTRATION AND ENFORCEMENT OF PART 535.**
 16 **REVENUE DEPOSITED IN THE FOREST DEVELOPMENT FUND AS PROVIDED UNDER**
 17 **SECTION 53519 SHALL BE USED ONLY AS PROVIDED IN THIS SUBDIVISION.**

18 **(E)** ~~(d)~~ For any other purposes authorized by this part.

19 (5) The auditor general shall audit the expenditures of the
 20 forest development fund at least once every 3 years.

21 ~~— (6) For fiscal year 2015-2016 only, \$3,000,000.00 from the~~
 22 ~~forest development fund is transferred to the first responder~~
 23 ~~presumed coverage fund created under section 405 of the worker's~~
 24 ~~disability compensation act of 1969, 1969 PA 317, MCL 418.405.~~

25 Sec. 50703. A county forestry committee is created for
 26 purposes of this part and shall consist of 5 members who shall be
 27 appointed by the county board of commissioners. Two members of the

1 county forestry committee shall be foresters registered under
2 ~~article 21 of the occupational code, Act No. 299 of the Public Acts~~
3 ~~of 1980, being sections 339.2101 to 339.2108 of the Michigan~~
4 ~~Compiled Laws, PART 535,~~ 1 member shall be a member of the county
5 economic development corporation, 1 member shall be a member of the
6 county board of commissioners, and 1 member shall be a resident of
7 the county who is not a county official or employee. If the county
8 has not established an economic development corporation under the
9 economic development corporations act, ~~Act No. 338 of the Public~~
10 ~~Acts of 1974, being sections~~ **1974 PA 338, MCL** 125.1601 to 125.1636,
11 ~~of the Michigan Compiled Laws,~~ 2 members shall be residents of the
12 county who are not county officials or employees. The members of
13 the county forestry committee shall be appointed for a term of 4
14 years, except that of the first appointments, 2 shall be for a term
15 of 4 years, 1 shall be for a term of 3 years, 1 shall be for a term
16 of 2 years, and 1 shall be for a term of 1 year. All actions of the
17 county forestry committee shall be approved by the county board of
18 commissioners. A vacancy on the county forestry committee shall be
19 filled by the county board of commissioners for the remainder of
20 the unexpired term.

21 Sec. 50706. Within 30 days after the execution of a lease
22 authorized by this part, the county forestry committee shall submit
23 to the department for approval a forest management plan prepared by
24 a forester registered under ~~article 21 of the occupational code,~~
25 ~~Act No. 299 of the Public Acts of 1980, being sections 339.2101 to~~
26 ~~339.2108 of the Michigan Compiled Laws.~~ **PART 535.**

27 Sec. 51101. As used in this part:

1 (a) "Ad valorem general property tax" means taxes levied under
2 the general property tax act, 1893 PA 206, MCL 211.1 to
3 ~~211.157.~~**211.155.**

4 (b) "Commercial forest" or "commercial forestland" means
5 forestland that is determined to be a commercial forest under
6 section ~~51103.~~**51104.**

7 (c) "Declassify" or "declassification" means the removal of
8 the commercial forest designation pursuant to section 51116.

9 (d) "Forestland" means a tract of land that may include
10 nonproductive land that is intermixed with productive land that is
11 an integral part of a managed forest and that meets all the
12 following:

13 (i) Does not have material natural resources other than those
14 resources suitable for forest growth or the potential for forest
15 growth.

16 (ii) Is not used for agricultural, mineral extraction except
17 as provided in section 51113, grazing, industrial, developed
18 recreational, residential, resort, commercial, or developmental
19 purposes.

20 (iii) The owner agrees to develop, maintain, and actively
21 manage the land as a commercial forest through planting, natural
22 reproduction, or other silvicultural practices.

23 (e) "Forest management plan" means a written plan prepared and
24 signed by a registered forester or a natural resources professional
25 that prescribes measures to optimize production, utilization, and
26 regeneration of forest resources. The forest management plan shall
27 include schedules and timetables for the various silvicultural

practices used on commercial forestlands, including, but not limited to, timber harvesting and regeneration.

(f) "Fund" means the commercial forest fund created under section 51112.

(g) "Natural resources professional" means a person who is acknowledged by the department as having the education, knowledge, experience, and skills to identify, schedule, and implement appropriate forest management practices needed to achieve the purposes of this part on land subject to or to be subject to this part.

(h) "Owner" means a person who holds title to the surface estate of forestland subject to this part. However, if land is purchased on a land contract, the owner includes the person who holds the land contract vendee's interest and does not include the person who holds the land contract vendor's interest.

(i) "Personal use" means use for any noncommercial purpose.

(j) "Registered forester" means a person registered under ~~article 21 of the occupational code, 1980 PA 299, MCL 339.2101 to 339.2108.~~ **PART 535.**

(k) "Silvicultural practices" means the management and manipulation of forest vegetation for the protection, growth, and enhancement of forest products.

PART 535. REGISTERED FORESTERS

SEC. 53501. AS USED IN THIS PART:

(A) "BOARD" MEANS THE BOARD OF FORESTERS CREATED IN SECTION 53505(1) .

(B) "DEPARTMENT" MEANS THE DEPARTMENT OF NATURAL RESOURCES.

1 (C) "FOREST DEVELOPMENT FUND" MEANS THE FOREST DEVELOPMENT
2 FUND CREATED IN SECTION 50507.

3 (D) "FORESTER" MEANS AN INDIVIDUAL WHO, BY REASON OF HIS OR
4 HER KNOWLEDGE OF THE NATURAL SCIENCES, MATHEMATICS, AND THE
5 PRINCIPLES OF FORESTRY, ACQUIRED BY FORESTRY EDUCATION AND
6 PRACTICAL EXPERIENCE, IS QUALIFIED TO ENGAGE IN THE PRACTICE OF
7 PROFESSIONAL FORESTRY.

8 (E) "PRACTICE OF PROFESSIONAL FORESTRY" MEANS THE SCIENCE,
9 ART, AND PRACTICE OF CREATING, MANAGING, USING, PLANNING AND
10 RESEARCHING, AND CONSERVING FORESTS AND ASSOCIATED RESOURCES FOR
11 HUMAN BENEFIT AND IN A SUSTAINABLE MANNER TO MEET DESIRED GOALS,
12 NEEDS, AND VALUES.

13 (F) "REGISTERED FORESTER" MEANS A FORESTER REGISTERED UNDER
14 SECTION 53509.

15 (G) "SAF" MEANS SOCIETY OF AMERICAN FORESTERS.

16 (H) "STATE FORESTER" MEANS THAT TERM AS DEFINED IN SECTION
17 50502.

18 (I) "VIOLATIONS COMMITTEE" MEANS THE VIOLATIONS COMMITTEE
19 APPOINTED UNDER SECTION 53505.

20 SEC. 53503. (1) THE DEPARTMENT SHALL TIMELY REVIEW EACH
21 REGISTERED FORESTER PROGRAM EVALUATION PROVIDED UNDER SECTION
22 53507.

23 (2) THE DEPARTMENT MAY CEASE ADMINISTERING THIS PART IF EITHER
24 OF THE FOLLOWING APPLIES:

25 (A) THE REVENUE AVAILABLE FROM REGISTERED FORESTER FEES UNDER
26 SECTION 53509 IS NOT SUFFICIENT TO ADMINISTER THIS PART.

27 (B) THE DEPARTMENT AND THE BOARD AGREE TO SEPARATE AND CEASE

1 OPERATIONS UNDER THIS PART.

2 SEC. 53505. (1) THE BOARD OF FORESTERS IS AN INDEPENDENT SELF-
3 DIRECTED BODY APPOINTED BY THE STATE FORESTER AND CREATED WITHIN
4 THE DEPARTMENT.

5 (2) TO BE ELIGIBLE TO SERVE ON THE BOARD, AN INDIVIDUAL MUST
6 BE A CITIZEN OF THE UNITED STATES AND A FULL-TIME RESIDENT OF THIS
7 STATE AND MUST HAVE AT LEAST 10 YEARS OF PROFESSIONAL FORESTRY
8 EXPERIENCE. THE BOARD SHALL CONSIST OF NOT FEWER THAN 5 OR MORE
9 THAN 7 OF THE FOLLOWING INDIVIDUALS, WHO SHALL BE APPOINTED BY THE
10 STATE FORESTER FROM AND NOMINATED BY THE GROUP REPRESENTED:

11 (A) AN INDIVIDUAL REPRESENTING THE ASSOCIATION OF CONSULTING
12 FORESTERS.

13 (B) AN INDIVIDUAL REPRESENTING THE SOCIETY OF AMERICAN
14 FORESTERS.

15 (C) AN INDIVIDUAL REPRESENTING THE FORESTRY PROGRAM FACULTY OF
16 A UNIVERSITY WHOSE FORESTRY PROGRAM IS ACCREDITED BY THE SAF.

17 (D) AN INDIVIDUAL REPRESENTING STATE AGENCIES THAT HAVE
18 FORESTRY STAFF.

19 (E) AN INDIVIDUAL REPRESENTING FOREST PRODUCTS ADVOCACY OR THE
20 FOREST PRODUCTS INDUSTRY, INCLUDING LOGGING.

21 (F) AN INDIVIDUAL REPRESENTING PRIVATE FOREST LANDOWNERS.

22 (G) AN INDIVIDUAL REPRESENTING A MUNICIPAL, URBAN, OR
23 COMMUNITY FORESTRY FIELD.

24 (3) THE MEMBERS FIRST APPOINTED TO THE BOARD SHALL BE
25 APPOINTED WITHIN 60 DAYS AFTER THE EFFECTIVE DATE OF THE AMENDATORY
26 ACT THAT ADDED THIS PART.

27 (4) MEMBERS OF THE BOARD SHALL SERVE FOR TERMS OF 4 YEARS OR

1 UNTIL A SUCCESSOR IS APPOINTED, WHICHEVER IS LATER, EXCEPT THAT, OF
2 THE MEMBERS FIRST APPOINTED, 3 SHALL SERVE FOR 2 YEARS.

3 (5) IF A VACANCY OCCURS ON THE BOARD, THE STATE FORESTER SHALL
4 MAKE AN APPOINTMENT FOR THE UNEXPIRED TERM IN THE SAME MANNER AS
5 THE ORIGINAL APPOINTMENT. THE STATE FORESTER MAY REMOVE A MEMBER OF
6 THE BOARD FOR INCOMPETENCE, DERELICTION OF DUTY, MALFEASANCE,
7 MISFEASANCE, OR NONFEASANCE IN OFFICE, OR ANY OTHER GOOD CAUSE.

8 (6) THE STATE FORESTER SHALL CALL THE FIRST MEETING OF THE
9 BOARD. AT THE FIRST MEETING, THE BOARD SHALL ELECT FROM AMONG ITS
10 MEMBERS A CHAIRPERSON, VICE-CHAIRPERSON, SECRETARY, AND OTHER
11 OFFICERS AS IT CONSIDERS APPROPRIATE. OFFICERS OF THE BOARD SHALL
12 SERVE FOR TERMS OF 2 YEARS. AFTER THE FIRST MEETING, THE BOARD
13 SHALL MEET ONCE ANNUALLY IN PERSON AND ONCE ANNUALLY BY CONFERENCE
14 CALL OR VIDEO CONFERENCE, OR MORE FREQUENTLY AT THE CALL OF THE
15 CHAIRPERSON OR IF REQUESTED BY 2 OR MORE MEMBERS.

16 (7) FIVE OR MORE MEMBERS OF THE BOARD CONSTITUTE A QUORUM FOR
17 THE TRANSACTION OF BUSINESS AT A MEETING OF THE BOARD. A MAJORITY
18 OF THE MEMBERS PRESENT AND SERVING ARE REQUIRED FOR OFFICIAL ACTION
19 OF THE BOARD.

20 (8) BUSINESS THAT THE BOARD MAY PERFORM SHALL BE CONDUCTED AT
21 A PUBLIC MEETING OF THE BOARD HELD IN COMPLIANCE WITH THE OPEN
22 MEETINGS ACT, 1976 PA 267, MCL 15.261 TO 15.275. THE SECRETARY OF
23 THE BOARD SHALL RECORD ALL PROCEEDINGS OF THE BOARD.

24 (9) A WRITING PREPARED, OWNED, USED, IN THE POSSESSION OF, OR
25 RETAINED BY THE BOARD IN THE PERFORMANCE OF AN OFFICIAL FUNCTION IS
26 SUBJECT TO THE FREEDOM OF INFORMATION ACT, 1976 PA 442, MCL 15.231
27 TO 15.246.

1 (10) MEMBERS OF THE BOARD SHALL SERVE WITHOUT COMPENSATION.
2 HOWEVER, MEMBERS OF THE BOARD MAY BE REIMBURSED FOR THEIR ACTUAL
3 AND NECESSARY EXPENSES INCURRED IN THE PERFORMANCE OF THEIR
4 OFFICIAL DUTIES AS MEMBERS OF THE BOARD.

5 (11) FOR THE PURPOSES OF SECTION 53517, THE CHAIRPERSON OF THE
6 BOARD SHALL APPOINT A VIOLATIONS COMMITTEE CONSISTING OF 3 MEMBERS
7 OF THE BOARD. MEMBERS OF THE VIOLATIONS COMMITTEE SHALL SERVE ON
8 THE COMMITTEE FOR TERMS OF 2 YEARS.

9 SEC. 53507. (1) THE BOARD SHALL DO ALL OF THE FOLLOWING:

10 (A) ADOPT BYLAWS.

11 (B) COMPLY WITH SECTION 53515.

12 (C) MAKE AVAILABLE A LIST OF REGISTERED FORESTERS. THE
13 DEPARTMENT SHALL POST THE LIST ON ITS WEBSITE.

14 (D) MAKE AN ANNUAL REPORT TO THE STATE FORESTER ON
15 PROCEEDINGS, APPLICATIONS, RENEWALS, COMPLAINTS, AND HEARINGS UNDER
16 THIS PART.

17 (E) ON A BIENNIAL BASIS, PROVIDE THE DEPARTMENT AN EVALUATION
18 OF THE REGISTERED FORESTER PROGRAM, INCLUDING BOTH OF THE
19 FOLLOWING:

20 (i) THE NUMBER OF REGISTERED FORESTERS, ECONOMIC DATA, AND
21 OTHER RELEVANT PROGRAM DATA.

22 (ii) THE SUFFICIENCY OF THE FEE UNDER SECTION 53509 TO OPERATE
23 A FISCALLY SOUND PROGRAM. THE DEPARTMENT MAY RECOMMEND TO THE
24 LEGISLATURE CHANGES IN THE FEE.

25 (2) THE BOARD MAY CALL WITNESSES AND RECEIVE EVIDENCE IN
26 HEARINGS UNDER THIS PART.

27 SEC. 53509. (1) TO BE REGISTERED AS A FORESTER, AN INDIVIDUAL

1 SHALL SUBMIT AN APPLICATION TO THE BOARD ON A FORM PROVIDED BY THE
2 DEPARTMENT. THE APPLICATION SHALL INCLUDE ALL OF THE FOLLOWING:

3 (A) THE NAME, ADDRESS, TELEPHONE NUMBER, AND ELECTRONIC MAIL
4 ADDRESS OF THE APPLICANT.

5 (B) INFORMATION DEMONSTRATING THAT THE INDIVIDUAL MEETS 1 OR
6 MORE OF THE FOLLOWING EDUCATIONAL REQUIREMENTS:

7 (i) AN ASSOCIATE'S DEGREE IN FORESTRY FROM AN SAF-ACCREDITED
8 UNIVERSITY PROGRAM OR BOARD-APPROVED PROGRAM, PLUS 4 YEARS OF
9 EXPERIENCE UNDER THE GUIDANCE OF A REGISTERED FORESTER, AN SAF-
10 CERTIFIED FORESTER, OR A MEMBER OF THE ASSOCIATION OF CONSULTING
11 FORESTERS.

12 (ii) A BACHELOR'S DEGREE IN FORESTRY FROM AN SAF-ACCREDITED
13 UNIVERSITY PROGRAM OR A BOARD-APPROVED PROGRAM, PLUS 2 YEARS OF
14 FORESTRY EXPERIENCE AS DESCRIBED IN SUBPARAGRAPH (i) .

15 (iii) A BACHELOR'S DEGREE IN A NATURAL RESOURCE FIELD FROM AN
16 SAF-ACCREDITED UNIVERSITY PROGRAM OR A BOARD-APPROVED PROGRAM, PLUS
17 2 YEARS OF FORESTRY EXPERIENCE DESCRIBED IN SUBPARAGRAPH (i) .

18 (iv) A GRADUATE DEGREE IN FORESTRY FROM AN SAF-ACCREDITED
19 UNIVERSITY PROGRAM OR A BOARD-APPROVED PROGRAM, PLUS 2 YEARS OF
20 FORESTRY EXPERIENCE DESCRIBED IN SUBPARAGRAPH (i) .

21 (C) REFERENCES OR ENDORSEMENTS FROM 3 REGISTERED FORESTERS.

22 (D) VERIFICATION OF SUCCESSFUL COMPLETION OF ANY CONTINUING
23 EDUCATION REQUIRED BY THE BOARD.

24 (E) OTHER RELEVANT INFORMATION REQUIRED BY THE BOARD.

25 (2) THE BOARD SHALL GRANT OR DENY REGISTRATION WITHIN 30 DAYS
26 AFTER A COMPLETE APPLICATION IS FILED AND NOTIFY THE APPLICANT OF
27 ITS DETERMINATION IN WRITING. IF AN APPLICATION IS DENIED, THE

1 NOTIFICATION SHALL INCLUDE THE REASONS FOR THE DENIAL. IF THE
2 APPLICATION IS APPROVED, THE DEPARTMENT SHALL ISSUE A REGISTRATION
3 CERTIFICATE AND CERTIFICATION NUMBER TO THE APPLICANT. THE
4 REGISTRATION IS VALID FOR 2 YEARS.

5 (3) TO MAINTAIN REGISTRATION AS A FORESTER, AN INDIVIDUAL
6 SHALL DO ALL OF THE FOLLOWING:

7 (A) PAY THE DEPARTMENT A FEE OF \$200.00 FOR THE REGISTRATION
8 PERIOD. THE FIRST PAYMENT SHALL BE MADE NOT MORE THAN 30 DAYS AFTER
9 THE APPLICATION FOR REGISTRATION IS GRANTED UNDER SUBSECTION (2).

10 (B) SUCCESSFULLY COMPLETE NOT FEWER THAN 24 HOURS OF
11 CONTINUING EDUCATION EVERY 2 YEARS AS APPROVED BY THE BOARD.

12 (C) DEMONSTRATE COMPLETION OF CONTINUING EDUCATION
13 REQUIREMENTS UNDER SUBDIVISION (B) AS A CONDITION FOR REGISTRATION
14 RENEWAL BY SUBMITTING EVIDENCE OF FULFILLMENT TO THE BOARD WITHIN
15 60 DAYS OF A REQUEST TO DO SO.

16 (D) MAINTAIN GOOD STANDING WITH THE BOARD BY COMPLYING WITH
17 SECTION 53515.

18 SEC. 53511. (1) THE BOARD SHALL DETERMINE WHETHER MEMBERS OF
19 AFFILIATED PROFESSIONAL ORGANIZATIONS WITHIN AND OUTSIDE OF THIS
20 STATE ARE ELIGIBLE FOR AUTOMATIC REGISTRATION UNDER THIS PART.

21 (2) THE BOARD SHALL REGISTER AN APPLICANT WHO IS A REGISTERED
22 OR LICENSED FORESTER IN ANOTHER STATE OR COUNTRY IF THE BOARD
23 CONSIDERS THE REQUIREMENTS OF THE STATE OR COUNTRY TO BE EQUIVALENT
24 TO THE REQUIREMENTS FOR REGISTRATION IN THIS STATE.

25 SEC. 53513. AN INDIVIDUAL SHALL NOT USE THE TITLE "REGISTERED
26 FORESTER" UNLESS HE OR SHE IS REGISTERED UNDER THIS PART.

27 SEC. 53515. A REGISTERED FORESTER SHALL COMPLY WITH ALL OF THE

1 FOLLOWING:

2 (A) IN HIS OR HER PROFESSIONAL CAPACITY, PERFORM THE FOLLOWING
3 GENERAL FORESTRY ACTIVITIES AS NECESSARY FOR THE PRACTICE OF
4 SUSTAINABLE FOREST MANAGEMENT AND SILVICULTURE:

5 (i) FOREST MANAGEMENT PLANNING.

6 (ii) FOREST STAND IMPROVEMENT.

7 (iii) FOREST MENSURATION, INVENTORY, FOREST PRODUCTS
8 APPRAISAL, AND TIMBER SALE ADMINISTRATION.

9 (iv) RECONNAISSANCE AND MAPPING OF FOREST AND WATERSHED LANDS;
10 INVESTIGATION OF WILDLAND SOILS; DELINEATION AND MAPPING OF
11 FORESTLANDS AND FOREST MANAGEMENT BOUNDARIES, NOT INCLUDING THE
12 ESTABLISHMENT OF PROPERTY CORNERS OR BOUNDARIES.

13 (v) PREPARATION AND UTILIZATION OF GIS/GPS MAPS, EQUIPMENT,
14 AND SOFTWARE TO ASSIST IN FOREST MANAGEMENT PLANNING, PLANTING,
15 HARVESTING, AND PROTECTION. GIS/GPS MAPS CREATED FOR FOREST
16 MANAGEMENT PURPOSES ARE NOT OFFICIAL SURVEY MAPS.

17 (vi) FOREST ECONOMICS.

18 (vii) FOREST UTILIZATION, RENEWABLE ENERGY PRODUCTION, AND
19 FOREST PRODUCT DEVELOPMENT.

20 (viii) FOREST PROTECTION AND RESTORATION.

21 (ix) FOREST REGENERATION, REFORESTATION, AND AFFORESTATION.

22 (x) FOREST NURSERY PRODUCTION.

23 STATEMENTS ON THE VALUE OF INDIVIDUAL TREES, TIMBER, OR

3 (G) NOT INTERFERE WITH COMPETITIVE BIDDING FOR FORESTRY
4 PROJECTS, INCLUDING MAKING FALSE REPRESENTATIONS OR MISLEADING
5 STATEMENTS ABOUT BIDDERS, PROSPECTIVE BIDDERS, OR COMPETITORS.

6 (H) NOT ISSUE A FORESTRY PLAN, MAP, SPECIFICATION, OR REPORT

8 SUPERVISION UNLESS IT IS ENDORSED WITH THE REGISTERED FORESTER'S

10 (I) NOT ENDORSE A FORESTRY PLAN, SPECIFICATION, ESTIMATE, OR
11 MAP UNLESS PREPARED BY THAT REGISTERED FORESTER OR UNDER HIS OR HER
12 ACTUAL SUPERVISION.

13 (J) PROVIDE FORESTRY SERVICES IN A MANNER THAT WILL ENSURE THE
14 PUBLIC HEALTH, SAFETY, AND WELFARE AND IF, IN HIS OR HER
15 PROFESSIONAL JUDGMENT, ANY OF THESE ARE ENDANGERED, NOTIFY THE
16 CLIENT OR EMPLOYER AND GIVE APPROPRIATE RECOMMENDATIONS OR
17 INSTRUCTIONS.

18 (K) IF A CLIENT OR EMPLOYER FAILS OR REFUSES TO FOLLOW

1 (O) NOT TAKE FORESTRY PROJECT FUNDS UNDER FALSE PRETENSES AND
2 NOT ABANDON A FORESTRY PROJECT WITHOUT NOTIFYING THE CLIENT OR
3 EMPLOYER.

4 SEC. 53517. (1) A PERSON MAY SUBMIT TO THE CHAIRPERSON OF THE
5 BOARD A COMPLAINT ABOUT A VIOLATION OF SECTION 53515 OR OF AN ORDER
6 UNDER THIS SECTION. THE DEPARTMENT SHALL MAINTAIN ON ITS WEBSITE A
7 COMPLAINT FORM THAT CAN BE COMPLETED AND SUBMITTED TO THE
8 CHAIRPERSON OF THE BOARD ONLINE OR PRINTED AND COMPLETED. THE
9 DEPARTMENT SHALL ALSO MAKE COMPLAINT FORMS AVAILABLE AT CUSTOMER
