SUBSTITUTE FOR

HOUSE BILL NO. 5100

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 225 (MCL 257.225), as amended by 2014 PA 26.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 225. (1) Except as otherwise provided in this subsection
- 2 and subsection (6), a registration plate issued for a vehicle shall
- 3 be attached to the rear of the vehicle. A registration plate issued
- 4 for a truck tractor or road tractor shall be attached to the front
- 5 of the vehicle.
- 6 (2) A registration plate shall at all times be securely
- 7 fastened in a horizontal position to the vehicle for which the
- 8 plate is issued so as to prevent the plate from swinging. The plate
- 9 shall be attached at a height of not less than 12 inches from the

- 1 ground, measured from the bottom of the plate, in a place and
- 2 position that is clearly visible. The plate shall be maintained
- 3 free from foreign materials that obscure or partially obscure the
- 4 registration information and in a clearly legible condition. THE
- 5 ATTACHMENT TO THE REAR OF A VEHICLE OF A TOW BALL, BICYCLE RACK,
- 6 REMOVABLE HITCH, OR ANY OTHER DEVICE DESIGNED TO CARRY AN OBJECT ON
- 7 THE REAR OF A VEHICLE, INCLUDING THE OBJECT BEING CARRIED, DOES NOT
- 8 VIOLATE THIS SUBSECTION.
- **9** (3) A registration plate or an expiration tab on the
- 10 registration plate shall be of a different color designated by the
- 11 secretary of state with a marked contrast between the color of the
- 12 registration plate and the numerals or letters on the plate. The
- 13 secretary of state may provide a distinctive registration plate as
- 14 a replacement for a standard plate. To honor a special or
- 15 historical event, the secretary of state may provide a
- 16 commemorative plate as a replacement for a standard plate.
- 17 (4) A person shall not attach a name plate, insignia, or
- 18 advertising device to a registration plate in a manner that
- 19 obscures or partially obscures the registration information.
- 20 (5) A person shall not operate a motor vehicle that has a name
- 21 plate, insignia, or advertising device attached to a registration
- 22 plate in a manner that obscures or partially obscures the
- 23 registration information.
- 24 (6) A registration plate issued for a historic military
- 25 vehicle that is authorized to be operated on the roads of this
- 26 state is not required to be attached to the rear or the front of
- 27 the historic military vehicle unless the historic military vehicle

- 1 was originally manufactured with lighting and mounting provisions
- 2 for a registration plate. However, if the registration plate is not
- 3 attached to the exterior of the historic military vehicle, it shall
- 4 be present in the historic military vehicle to which it refers and
- 5 shall be made available upon demand of a police officer. As used in
- 6 this subsection, "historic military vehicle" means a vehicle,
- 7 including a trailer, regardless of the vehicle's size, weight, or
- 8 year of manufacture, that was manufactured for use in any country's
- 9 military forces and is maintained to represent its military design
- 10 and markings accurately.
- 11 (7) A person who violates this section is responsible for a
- 12 civil infraction.
- 13 Enacting section 1. This amendatory act takes effect 90 days
- 14 after the date it is enacted into law.
