

# HOUSE BILL No. 5052

October 3, 2017, Introduced by Reps. Jones and Marino and referred to the Committee on Local Government.

A bill to amend 1913 PA 275, entitled

"An act to authorize the boards of supervisors of counties to create a board of county auditors, appoint such officers, and prescribe their powers, duties and compensation,"

by amending section 5 (MCL 47.5).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1       Sec. 5. The board of ~~supervisors~~ **COMMISSIONERS** of any county  
2 ~~instead of electing all the members of the board of auditors may~~  
3 ~~elect by ballot~~ **APPOINT** a board of county auditors of not to exceed  
4 3 members, 1 of whom the **COUNTY** board of ~~supervisors~~ **COMMISSIONERS**  
5 shall designate as ~~chairman~~ **CHAIRPERSON** of the board of county  
6 auditors. If the board of county auditors consists of 1 ~~man, he~~  
7 ~~shall be elected~~ **INDIVIDUAL, THAT INDIVIDUAL MUST BE APPOINTED** for  
8 a term of 1 year. ~~if~~ **IF** the board consists of 2 ~~men,~~ **INDIVIDUALS,**  
9 1 ~~shall be elected~~ **MUST BE APPOINTED** for a term of 1 year ~~and 1~~  
10 **MUST BE APPOINTED** for a term of 2 years. ~~if~~ **IF** the board consists

1 of 3 ~~men~~, **INDIVIDUALS**, 1 ~~shall be elected~~ **MUST BE APPOINTED** for A  
 2 **TERM OF** 1 year, 1 **MUST BE APPOINTED** for A **TERM OF** 2 years, and 1  
 3 **MUST BE APPOINTED** for A **TERM OF** 3 years. The term of office of each  
 4 of these members ~~shall begin~~ **BEGINS** on the following January 1. At  
 5 each October session of the **COUNTY** board of ~~supervisors preceding~~  
 6 **COMMISSIONERS BEFORE** the expiration of the term of office of each  
 7 of the individual members of the board, ~~his~~ A successor ~~shall~~ **MUST**  
 8 be appointed by the **COUNTY** board of ~~supervisors~~ **COMMISSIONERS** for a  
 9 term of 3 years from the following January 1. Every person ~~so~~  
 10 ~~elected~~ **APPOINTED** shall hold for the term of office indicated and  
 11 until his **OR HER** successor is ~~elected~~ **APPOINTED** and qualified. ~~No~~ A  
 12 person shall **NOT** be ~~deemed elected~~ **CONSIDERED APPOINTED** as a member  
 13 of the board of county auditors who ~~shall~~ **DOES** not receive a  
 14 majority vote of all the members of the **COUNTY** board of  
 15 ~~supervisors. Whenever~~ **COMMISSIONERS. IF** a vacancy occurs in the  
 16 board of **COUNTY** auditors, ~~it shall~~ **THE VACANCY MUST** be filled by  
 17 the **COUNTY** board of ~~supervisors, except in counties now or~~  
 18 ~~hereafter having a population of 1,500,000 or more, vacancies shall~~  
 19 ~~be filled as provided in section 239 of Act No. 116 of the Public~~  
 20 ~~Acts of 1954, being section 168.239 of the Compiled Laws of 1948,~~  
 21 **COMMISSIONERS**, and ~~such~~ **THE** appointment ~~shall be~~ **IS** for the  
 22 unexpired term of the vacancy ~~so~~ filled. ~~No~~ A person holding any  
 23 office either elective or appointive under any county adopting this  
 24 act, or any of the townships of the county, or of ~~the~~ **THIS** state,  
 25 and ~~no~~ A person not an elector of the county, ~~shall be~~ **IS NOT**  
 26 eligible to hold the office of county auditor. No more than 2  
 27 members of any board of **COUNTY** auditors shall be affiliated with

1 the same political party.

2 Enacting section 1. This amendatory act takes effect 90 days  
3 after the date it is enacted into law.

4 Enacting section 2. This amendatory act does not take effect  
5 unless all of the following bills of the 99th Legislature are  
6 enacted into law:
