## SUBSTITUTE FOR HOUSE BILL NO. 5122

A bill to amend 1994 PA 203, entitled "Foster care and adoption services act,"

(MCL 722.951 to 722.960) by adding section 8c.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 8C. IN ADDITION TO THE SPECIFIC POLICY DESCRIBED IN
- 2 SECTIONS 8B AND 8D, THE DEPARTMENT SHALL DRAFT AND MAINTAIN A
- 3 SPECIFIC POLICY FOR CHILDREN IN FOSTER CARE AS PROVIDED IN THIS
- 4 SECTION. THIS SPECIFIC POLICY SHALL BE IMPLEMENTED BY NO LATER THAN
- 5 90 DAYS AFTER THE EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED
- 6 THIS SECTION AND SHALL, IN ADDITION TO THE PROVISIONS OF SECTIONS
- 7 8B AND 8D, ADDRESS THE CHILD IN FOSTER CARE'S ACCESS TO THE
- 8 FOLLOWING AS AGE-APPROPRIATE AND AS MANDATED BY THE COURT:
- 9 (A) REGULAR CONTACT WITH ALL OF THE CHILD IN FOSTER CARE'S
- 10 CASEWORKERS, ATTORNEYS, AND ADVOCATES.

- 1 (B) RELEVANT INFORMATION REGARDING A CHANGE IN THE CHILD IN
- 2 FOSTER CARE'S CASEWORKER OR ATTORNEY.
- 3 (C) REASONABLE NOTIFICATION OF HEARINGS.
- 4 (D) AT 14 YEARS OF AGE OR OLDER, INVOLVEMENT IN THE CHILD IN
- 5 FOSTER CARE'S OWN CASE PLAN DEVELOPMENT AND DEVELOPMENT OF A PLAN
- 6 FOR HIS OR HER FUTURE AND AGING OUT OF THE FOSTER CARE SYSTEM.
- 7 (E) HELP WITH UNDERSTANDING THE SERVICES AVAILABLE TO CHILDREN
- 8 IN FOSTER CARE AND HOW TO ACCESS THOSE SERVICES.
- 9 (F) A PERMANENT PLAN FOR PLACEMENT AND THE CHILD IN FOSTER
- 10 CARE'S PARTICIPATION IN THE DEVELOPMENT OF THAT PLAN.
- 11 (G) PROTECTION OF THE CHILD IN FOSTER CARE'S PRIVACY AND
- 12 CONFIDENTIALITY REGARDING HIS OR HER CASE.
- 13 Enacting section 1. This amendatory act takes effect 90 days
- 14 after the date it is enacted into law.
- 15 Enacting section 2. This amendatory act does not take effect
- 16 unless all of the following bills of the 99th Legislature are
- 17 enacted into law:
