HOUSE BILL No. 5220

by amending section 224d (MCL 750.224d), as amended by 2010 PA 365.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 224d. (1) As used in this section and section 224, "self-defense spray or foam device" means a device to which all of the following apply:
 - (a) The device is capable of carrying, and ejects, releases, or emits 1 of the following:
 - (i) Not more than 35 grams of any combination of orthochlorobenzalmalononitrile and inert ingredients.
 - (ii) A solution containing not more than $\frac{10\%}{18\%}$ oleoresin capsicum.
 - (iii) A SOLUTION CONTAINING AN ULTRAVIOLET DYE AND NOT MORE THAN 18% OLEORESIN CAPSICUM.

- 1 (b) The device does not eject, release, or emit any gas or
- 2 substance that will temporarily or permanently disable,
- 3 incapacitate, injure, or harm a person with whom the gas or
- 4 substance comes in contact, other than the substance described in
- 5 subdivision (a) (i), $\frac{\text{or}}{\text{or}}$ (ii), OR (iii).
- 6 (2) Except as otherwise provided in this section, a person who
- 7 uses a self-defense spray or foam device to eject, release, or emit
- 8 orthochlorobenzalmalononitrile or oleoresin capsicum at another
- 9 person is guilty of a misdemeanor, punishable by imprisonment for
- 10 not more than 2 years, or a fine of not more than \$2,000.00, or
- 11 both.
- 12 (3) If a person uses a self-defense spray or foam device
- 13 during the commission of a crime to eject, release, or emit
- 14 orthochlorobenzalmalononitrile or oleoresin capsicum or threatens
- 15 to use a self-defense spray or foam device during the commission of
- 16 a crime to temporarily or permanently disable another person, the
- 17 judge who imposes sentence upon a conviction for that crime shall
- 18 consider the defendant's use or threatened use of the self-defense
- 19 spray or foam device as a reason for enhancing the sentence.
- 20 (4) A person shall not sell a self-defense spray or foam
- 21 device to a minor. A person who violates this subsection is quilty
- of a misdemeanor punishable by imprisonment for not more than 90
- 23 days or a fine of not more than \$500.00, or both.
- 24 (5) Subsection (2) does not prohibit either of the following:
- 25 (a) The reasonable use of a self-defense spray or foam device
- 26 containing not more than 10%-18% oleoresin capsicum by a person who
- 27 is employed by a county sheriff or a chief of police and who is

- 5 (b) The reasonable use of a self-defense spray or foam device
- 6 containing not more than 10% oleoresin capsicum EITHER OF THE
- 7 **FOLLOWING** by a person in the protection of a person or property
- 8 under circumstances that would justify the person's use of physical
- 9 force: -
- 10 (i) A SELF-DEFENSE SPRAY OR FOAM DEVICE CONTAINING NOT MORE
- 11 THAN 18% OLEORESIN CAPSICUM.
- 12 (ii) A SELF-DEFENSE SPRAY OR FOAM DEVICE CONTAINING AN
- 13 ULTRAVIOLET DYE AND NOT MORE THAN 18% OLEORESIN CAPSICUM.
