- 9 IDENTIFICATION CARD FILE, AND ENHANCED STATE PERSONAL
- 10 IDENTIFICATION CARD FILE FOR AUTHENTICATION PURPOSES.

- 1 (C) AUTHENTICATE THE IDENTITY OF AN APPLICANT UNDER A PROCESS
- 2 DEVELOPED BY THE SECRETARY OF STATE THAT INCLUDES, BUT IS NOT
- 3 LIMITED TO, VERIFYING ALL OF THE FOLLOWING:
- 4 (i) THE LAST 4 DIGITS OF THE APPLICANT'S SOCIAL SECURITY
- 5 NUMBER.
- 6 (ii) THE APPLICANT'S OPERATOR'S OR CHAUFFEUR'S LICENSE NUMBER,
- 7 ENHANCED DRIVER LICENSE NUMBER, OFFICIAL STATE PERSONAL
- 8 IDENTIFICATION CARD NUMBER, OR ENHANCED OFFICIAL STATE PERSONAL
- 9 IDENTIFICATION CARD NUMBER.
- 10 (iii) THE APPLICANT'S FULL NAME AS PRINTED ON HIS OR HER

- 14 (iv) THE APPLICANT'S DATE OF BIRTH.
- 15 (v) THE APPLICANT'S EYE COLOR AS PRINTED ON HIS OR HER
- 16 OPERATOR'S OR CHAUFFEUR'S LICENSE, ENHANCED DRIVER LICENSE,
- 17 OFFICIAL STATE PERSONAL IDENTIFICATION CARD, OR ENHANCED OFFICIAL
- 18 STATE PERSONAL IDENTIFICATION CARD.
- 19 (D) REQUIRE THE APPLICANT'S ASSENT TO SUBMIT A VOTER
- 20 REGISTRATION APPLICATION ELECTRONICALLY AND REQUIRE THE APPLICANT'S
- 21 ASSENT TO USE HIS OR HER MOST RECENT DIGITIZED SIGNATURE IF
- 22 CAPTURED OR REPRODUCED BY THE SECRETARY OF STATE UNDER SECTION 307
- 23 OF THE MICHIGAN VEHICLE CODE, 1949 PA 300, MCL 257.307, SECTION 5
- 24 OF THE ENHANCED DRIVER LICENSE AND ENHANCED OFFICIAL STATE PERSONAL
- 25 IDENTIFICATION CARD ACT, 2008 PA 23, MCL 28.305, OR 1972 PA 222,
- 26 MCL 28.291 TO 28.300.
- 27 (E) ISSUE A RECEIPT TO THE APPLICANT IN THE MANNER PRESCRIBED

- 1 BY THE SECRETARY OF STATE.
- 2 (F) UTILIZE ADDITIONAL SECURITY FEATURES CONSIDERED
- 3 APPROPRIATE BY THE SECRETARY OF STATE OR THE DEPARTMENT OF
- 4 TECHNOLOGY, MANAGEMENT, AND BUDGET TO PREVENT UNAUTHORIZED ACCESS
- 5 TO DATA OR INFORMATION, OR TO ENSURE THAT A PERSON ATTEMPTING TO
- 6 USE THE ELECTRONIC VOTER REGISTRATION INTERFACE IS AN INDIVIDUAL.
- 7 (2) THE SECRETARY OF STATE SHALL DEVELOP AN ELECTRONIC VOTER
- 8 REGISTRATION APPLICATION THAT INCLUDES ALL OF THE SAME INFORMATION
- 9 AS PROVIDED ON THE MAIL REGISTRATION FORM DEVELOPED BY THE
- 10 SECRETARY OF STATE UNDER SECTION 509N(A), AND ALSO INCLUDES THE
- 11 NOTICE REQUIRED UNDER SECTION 307(1)(C) OF THE MICHIGAN VEHICLE
- 12 CODE, 1949 PA 300, MCL 257.307.
- 13 (3) ONLY AN INDIVIDUAL WHO POSSESSES BOTH OF THE FOLLOWING IS
- 14 ELIGIBLE TO SUBMIT AN ELECTRONIC VOTER REGISTRATION APPLICATION:
- 15 (A) THE QUALIFICATIONS OF AN ELECTOR AS PROVIDED IN SECTION
- 16 492.
- 17 (B) A VALID OFFICIAL STATE PERSONAL IDENTIFICATION CARD ISSUED
- 18 UNDER 1972 PA 222, MCL 28.291 TO 28.300, AN ENHANCED OFFICIAL STATE
- 19 PERSONAL IDENTIFICATION CARD ISSUED UNDER THE ENHANCED DRIVER
- 20 LICENSE AND ENHANCED OFFICIAL STATE PERSONAL IDENTIFICATION CARD
- 21 ACT, 2008 PA 23, MCL 28.301 TO 28.308, A VALID OPERATOR'S OR
- 22 CHAUFFEUR'S LICENSE ISSUED UNDER THE MICHIGAN VEHICLE CODE, 1949 PA
- 23 300, MCL 257.1 TO 257.923, OR AN ENHANCED DRIVER LICENSE ISSUED
- 24 UNDER THE ENHANCED DRIVER LICENSE AND ENHANCED OFFICIAL STATE
- 25 PERSONAL IDENTIFICATION CARD ACT, 2008 PA 23, MCL 28.301 TO 28.308.
- 26 (4) IF AN ELECTOR UTILIZES THE ELECTRONIC VOTER REGISTRATION
- 27 INTERFACE TO INDICATE A CHANGE OF ADDRESS, THE STATE BUREAU OF

- 1 ELECTIONS SHALL SEND A CONFIRMATION NOTICE TO THE ELECTOR'S
- 2 PREVIOUS ADDRESS.
- 3 (5) AN INDIVIDUAL IS NOT PERMITTED TO USE THE ELECTRONIC VOTER
- 4 REGISTRATION INTERFACE IF THE INDIVIDUAL MEETS ANY OF THE FOLLOWING
- 5 CONDITIONS:
- 6 (A) THE INDIVIDUAL ORDERED A DUPLICATE OF AN OPERATOR'S OR
- 7 CHAUFFEUR'S LICENSE, AN ENHANCED DRIVER LICENSE, AN OFFICIAL STATE
- PERSONAL IDENTIFICATION CARD, OR AN ENHANCED OFFICIAL STATE 8
- PERSONAL IDENTIFICATION CARD THE SAME DAY AS SUBMITTING AN 9
- 10 ELECTRONIC VOTER REGISTRATION APPLICATION.
- 11 (B) THE INDIVIDUAL SUBMITTED A CHANGE OF ADDRESS FOR AN
- 12 OPERATOR'S OR CHAUFFEUR'S LICENSE, AN ENHANCED DRIVER LICENSE, AN
- OFFICIAL STATE PERSONAL IDENTIFICATION CARD, OR AN ENHANCED 13
- OFFICIAL STATE PERSONAL IDENTIFICATION CARD WITHIN THE 10 DAYS 14
- BEFORE SUBMITTING AN ELECTRONIC VOTER REGISTRATION APPLICATION. 15
- (C) THE INDIVIDUAL HAS AN EXPIRED OPERATOR'S OR CHAUFFEUR'S 16
- LICENSE, AN EXPIRED ENHANCED DRIVER LICENSE, AN EXPIRED OFFICIAL 17
- 18 STATE PERSONAL IDENTIFICATION CARD, OR AN EXPIRED ENHANCED OFFICIAL
- 19 STATE PERSONAL IDENTIFICATION CARD.
- 20 Enacting section 1. This amendatory act takes effect 90 days
- 21 after the date it is enacted into law.
- 22 Enacting section 2. This amendatory act does not take effect
- 23 unless House Bill No. 5549 of the 99th Legislature is enacted into
- 24 law.
