

**SUBSTITUTE FOR
HOUSE BILL NO. 5680**

A bill to amend 1893 PA 206, entitled
"The general property tax act,"
by amending sections 27 and 34d (MCL 211.27 and 211.34d), section
27 as amended by 2013 PA 162 and section 34d as amended by 2014 PA
164.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 27. (1) As used in this act, "true cash value" means the
2 usual selling price at the place where the property to which the
3 term is applied is at the time of assessment, being the price that
4 could be obtained for the property at private sale, and not at
5 auction sale except as otherwise provided in this section, or at
6 forced sale. The usual selling price may include sales at public

1 auction held by a nongovernmental agency or person if those sales
2 have become a common method of acquisition in the jurisdiction for
3 the class of property being valued. The usual selling price does
4 not include sales at public auction if the sale is part of a
5 liquidation of the seller's assets in a bankruptcy proceeding or if
6 the seller is unable to use common marketing techniques to obtain
7 the usual selling price for the property. A sale or other
8 disposition by this state or an agency or political subdivision of
9 this state of land acquired for delinquent taxes or an appraisal
10 made in connection with the sale or other disposition or the value
11 attributed to the property of regulated public utilities by a
12 governmental regulatory agency for rate-making purposes is not
13 controlling evidence of true cash value for assessment purposes. In
14 determining the true cash value, the assessor shall also consider
15 the advantages and disadvantages of location; quality of soil;
16 zoning; existing use; present economic income of structures,
17 including farm structures; present economic income of land if the
18 land is being farmed or otherwise put to income producing use;
19 quantity and value of standing timber; water power and privileges;
20 minerals, quarries, or other valuable deposits not otherwise exempt
21 under this act known to be available in the land and their value.
22 In determining the true cash value of personal property owned by an
23 electric utility cooperative, the assessor shall consider the
24 number of kilowatt hours of electricity sold per mile of
25 distribution line compared to the average number of kilowatt hours
26 of electricity sold per mile of distribution line for all electric
27 utilities.

(2) The assessor shall not consider the increase in true cash value that is a result of expenditures for normal repairs, replacement, and maintenance in determining the true cash value of property for assessment purposes until the property is sold. For the purpose of implementing this subsection, the assessor shall not increase the construction quality classification or reduce the effective age for depreciation purposes, except if the appraisal of the property was erroneous before nonconsideration of the normal repair, replacement, or maintenance, and shall not assign an economic condition factor to the property that differs from the economic condition factor assigned to similar properties as defined by appraisal procedures applied in the jurisdiction. The increase in value attributable to the items included in subdivisions (a) to ~~(e)~~ **(P)** that is known to the assessor and excluded from true cash value shall be indicated on the assessment roll. This subsection applies only to residential property. The following repairs are considered normal maintenance if they are not part of a structural addition or completion:

(a) Outside painting.

(b) Repairing or replacing siding, roof, porches, steps, sidewalks, or drives.

(c) Repainting, repairing, or replacing existing masonry.

(d) Replacing awnings.

(e) Adding or replacing gutters and downspouts.

(f) Replacing storm windows or doors.

(g) Insulating or weatherstripping.

(h) Complete rewiring.

(i) Replacing plumbing and light fixtures.

(j) Replacing a furnace with a new furnace of the same type or replacing an oil or gas burner.

(k) Repairing plaster, inside painting, or other redecorating.

(l) New ceiling, wall, or floor surfacing.

(m) Removing partitions to enlarge rooms.

(n) Replacing an automatic hot water heater.

(o) Replacing dated interior woodwork.

(P) INSTALLING, REPLACING, OR REPAIRING AN ALTERNATIVE ENERGY SYSTEM, WITHOUT REGARD TO OWNERSHIP OF THE SYSTEM, WITH A GENERATING CAPACITY OF NOT MORE THAN 150 KILOWATTS, THE ANNUAL ENERGY OUTPUT OF WHICH DOES NOT EXCEED THE ANNUAL ENERGY CONSUMPTION MEASURED BY THE UTILITY-PROVIDED ELECTRICAL METER ON THE SYSTEM TO WHICH IT IS CONNECTED. AS USED IN THIS SUBDIVISION, "ALTERNATIVE ENERGY SYSTEM" MEANS THAT TERM AS DEFINED IN SECTION 2 OF THE MICHIGAN NEXT ENERGY AUTHORITY ACT, 2002 PA 593, MCL 207.822.

(3) A city or township assessor, a county equalization department, or the state tax commission before utilizing real estate sales data on real property purchases, including purchases by land contract, to determine assessments or in making sales ratio studies to assess property or equalize assessments shall exclude from the sales data the following amounts allowed by subdivisions (a), (b), and (c) to the extent that the amounts are included in the real property purchase price and are so identified in the real estate sales data or certified to the assessor as provided in subdivision (d):

1 (a) Amounts paid for obtaining financing of the purchase price
2 of the property or the last conveyance of the property.

3 (b) Amounts attributable to personal property that were
4 included in the purchase price of the property in the last
5 conveyance of the property.

6 (c) Amounts paid for surveying the property pursuant to the
7 last conveyance of the property. The legislature may require local
8 units of government, including school districts, to submit reports
9 of revenue lost under subdivisions (a) and (b) and this subdivision
10 so that the state may reimburse those units for that lost revenue.

11 (d) The purchaser of real property, including a purchaser by
12 land contract, may file with the assessor of the city or township
13 in which the property is located 2 copies of the purchase agreement
14 or of an affidavit that identifies the amount, if any, for each
15 item listed in subdivisions (a) to (c). One copy shall be forwarded
16 by the assessor to the county equalization department. The
17 affidavit shall be prescribed by the state tax commission.

18 (4) In finalizing sales studies for property classified as
19 agricultural real property under section 34c, an assessor and
20 equalization director shall determine if an affidavit for the
21 property has been filed under section ~~27a(7)(n)~~. **27A(7)(O)**. If an
22 affidavit has not been filed, the property shall be reviewed to
23 determine if classification as agricultural real property under
24 section 34c is correct or should be changed. The assessor for the
25 local tax collecting unit in which the property is located shall
26 contact the property owner to determine why the property owner did
27 not file an affidavit under section ~~27a(7)(n)~~. **27A(7)(O)**. Unless

1 there are convincing facts to the contrary, the sale of property
2 classified as agricultural real property under section 34c for
3 which an affidavit under section ~~27a(7)(n)~~**27A(7)(O)** has not been
4 filed shall not be included in a sales study.

5 (5) As used in subsection (1), "present economic income" means
6 for leased or rented property the ordinary, general, and usual
7 economic return realized from the lease or rental of property
8 negotiated under current, contemporary conditions between parties
9 equally knowledgeable and familiar with real estate values. The
10 actual income generated by the lease or rental of property is not
11 the controlling indicator of its true cash value in all cases. This
12 subsection does not apply to property subject to a lease entered
13 into before January 1, 1984 for which the terms of the lease
14 governing the rental rate or tax liability have not been
15 renegotiated after December 31, 1983. This subsection does not
16 apply to a nonprofit housing cooperative subject to regulatory
17 agreements between the state or federal government entered into
18 before January 1, 1984. As used in this subsection, "nonprofit
19 cooperative housing corporation" means a nonprofit cooperative
20 housing corporation that is engaged in providing housing services
21 to its stockholders and members and that does not pay dividends or
22 interest upon stock or membership investment but that does
23 distribute all earnings to its stockholders or members.

24 (6) Except as otherwise provided in subsection (7), the
25 purchase price paid in a transfer of property is not the
26 presumptive true cash value of the property transferred. In
27 determining the true cash value of transferred property, an

1 assessing officer shall assess that property using the same
2 valuation method used to value all other property of that same
3 classification in the assessing jurisdiction. As used in this
4 subsection and subsection (7), "purchase price" means the total
5 consideration agreed to in an arms-length transaction and not at a
6 forced sale paid by the purchaser of the property, stated in
7 dollars, whether or not paid in dollars.

8 (7) The purchase price paid in a transfer of eligible
9 nonprofit housing property from a charitable nonprofit housing
10 organization to a low-income person that occurs after December 31,
11 2010 is the presumptive true cash value of the eligible nonprofit
12 housing property transferred. In the year immediately succeeding
13 the year in which the transfer of eligible nonprofit housing
14 property occurs and each year thereafter, the taxable value of the
15 eligible nonprofit housing property shall be adjusted as provided
16 under section 27a. As used in this subsection:

17 (a) "Charitable nonprofit housing organization" means a
18 charitable nonprofit organization the primary purpose of which is
19 the construction or renovation of residential housing for
20 conveyance to a low-income person.

21 (b) "Eligible nonprofit housing property" means property owned
22 by a charitable nonprofit housing organization, the ownership of
23 which the charitable nonprofit housing organization intends to
24 transfer to a low-income person after construction or renovation of
25 the property is completed.

26 (c) "Family income" and "statewide median gross income" mean
27 those terms as defined in section 11 of the state housing

1 development authority act of 1966, 1966 PA 346, MCL 125.1411.

2 (d) "Low-income person" means a person with a family income of
3 not more than 60% of the statewide median gross income who is
4 eligible to participate in the charitable nonprofit housing
5 organization's program based on criteria established by the
6 charitable nonprofit housing organization.

7 (8) For purposes of a statement submitted under section 19,
8 the true cash value of a standard tool is the net book value of
9 that standard tool as of December 31 in each tax year as determined
10 using generally accepted accounting principles in a manner
11 consistent with the established depreciation method used by the
12 person submitting that statement. The net book value of a standard
13 tool for federal income tax purposes is not the presumptive true
14 cash value of that standard tool. As used in this subsection,
15 "standard tool" means that term as defined in section 9b.

16 Sec. 34d. (1) As used in this section or section 27a, or
17 section 3 or 31 of article IX of the state constitution of 1963:

18 (a) For taxes levied before 1995, "additions" means all
19 increases in value caused by new construction or a physical
20 addition of equipment or furnishings, and the value of property
21 that was exempt from taxes or not included on the assessment unit's
22 immediately preceding year's assessment roll.

23 (b) For taxes levied after 1994, "additions" means, except as
24 provided in subdivision (c), all of the following:

25 (i) Omitted real property. As used in this subparagraph,
26 "omitted real property" means previously existing tangible real
27 property not included in the assessment. Omitted real property

1 shall not increase taxable value as an addition unless the
2 assessing jurisdiction has a property record card or other
3 documentation showing that the omitted real property was not
4 previously included in the assessment. The assessing jurisdiction
5 has the burden of proof in establishing whether the omitted real
6 property is included in the assessment. Omitted real property for
7 the current and the 2 immediately preceding years, discovered after
8 the assessment roll has been completed, shall be added to the tax
9 roll pursuant to the procedures established in section 154. For
10 purposes of determining the taxable value of real property under
11 section 27a, the value of omitted real property is based on the
12 value and the ratio of taxable value to true cash value the omitted
13 real property would have had if the property had not been omitted.

14 (ii) Omitted personal property. As used in this subparagraph,
15 "omitted personal property" means previously existing tangible
16 personal property not included in the assessment. Omitted personal
17 property shall be added to the tax roll pursuant to section 154.

18 (iii) New construction. As used in this subparagraph, "new
19 construction" means property not in existence on the immediately
20 preceding tax day and not replacement construction. New
21 construction includes the physical addition of equipment or
22 furnishings, subject to the provisions set forth in section
23 27(2)(a) to ~~(e)~~. **(P)**. For purposes of determining the taxable value
24 of property under section 27a, the value of new construction is the
25 true cash value of the new construction multiplied by 0.50.

26 (iv) Previously exempt property. As used in this subparagraph,
27 "previously exempt property" means property that was exempt from ad

1 valorem taxation under this act on the immediately preceding tax
2 day but is subject to ad valorem taxation on the current tax day
3 under this act. For purposes of determining the taxable value of
4 real property under section 27a:

5 (A) The value of property previously exempt under section 7u
6 is the taxable value the entire parcel of property would have had
7 if that property had not been exempt, minus the product of the
8 entire parcel's taxable value in the immediately preceding year and
9 the lesser of 1.05 or the inflation rate.

10 (B) The taxable value of property that is a facility as that
11 term is defined in section 2 of 1974 PA 198, MCL 207.552, that was
12 previously exempt under section 7k is the taxable value that
13 property would have had under this act if it had not been exempt.

14 (C) The value of property previously exempt under any other
15 section of law is the true cash value of the previously exempt
16 property multiplied by 0.50.

17 (v) Replacement construction. As used in this subparagraph,
18 "replacement construction" means construction that replaced
19 property damaged or destroyed by accident or act of God and that
20 occurred after the immediately preceding tax day to the extent the
21 construction's true cash value does not exceed the true cash value
22 of property that was damaged or destroyed by accident or act of God
23 in the immediately preceding 3 years. Except as otherwise provided
24 in this subparagraph, for purposes of determining the taxable value
25 of property under section 27a, the value of the replacement
26 construction is the true cash value of the replacement construction
27 multiplied by a fraction, the numerator of which is the taxable

1 value of the property to which the construction was added in the
2 immediately preceding year and the denominator of which is the true
3 cash value of the property to which the construction was added in
4 the immediately preceding year, and then multiplied by the lesser
5 of 1.05 or the inflation rate. However, after December 31, 2011,
6 for purposes of determining the taxable value of property under
7 section 27a, if the property's replacement construction is of
8 substantially the same materials as determined by the state tax
9 commission, if the square footage is not more than 5% greater than
10 the property that was damaged or destroyed, and if the replacement
11 construction is completed not later than December 31 in the year 3
12 years after the accident or act of God occurred, the replacement
13 construction's taxable value shall be equal to the taxable value of
14 the property in the year immediately preceding the year in which
15 the property was damaged or destroyed, adjusted annually as
16 provided in section 27a(2). Any construction materials required to
17 bring the property into compliance with any applicable health,
18 sanitary, zoning, safety, fire, or construction codes or ordinances
19 shall be considered to be substantially the same materials by the
20 state tax commission for the sake of replacement construction under
21 this section.

22 (vi) An increase in taxable value attributable to the complete
23 or partial remediation of environmental contamination existing on
24 the immediately preceding tax day. The department of environmental
25 quality shall determine the degree of remediation based on
26 information available in existing department of environmental
27 quality records or information made available to the department of

1 environmental quality if the appropriate assessing officer for a
2 local tax collecting unit requests that determination. The increase
3 in taxable value attributable to the remediation is the increase in
4 true cash value attributable to the remediation multiplied by a
5 fraction, the numerator of which is the taxable value of the
6 property had it not been contaminated and the denominator of which
7 is the true cash value of the property had it not been
8 contaminated.

9 (vii) Public services. As used in this subparagraph, "public
10 services" means water service, sewer service, a primary access
11 road, natural gas service, electrical service, telephone service,
12 sidewalks, or street lighting. For purposes of determining the
13 taxable value of real property under section 27a, the value of
14 public services is the amount of increase in true cash value of the
15 property attributable to the available public services multiplied
16 by 0.50, and shall be added in the calendar year following the
17 calendar year when those public services are initially available.

18 (c) For taxes levied after 1994, additions do not include
19 increased value attributable to any of the following:

20 (i) Platting, splits, or combinations of property.

21 (ii) A change in the zoning of property.

22 (iii) For the purposes of the calculation of the millage
23 reduction fraction under subsection (7) only, increased taxable
24 value under section 27a(3) after a transfer of ownership of
25 property.

26 (d) "Assessed valuation of property as finally equalized"
27 means taxable value under section 27a.

1 (e) "Financial officer" means the officer responsible for
2 preparing the budget of a unit of local government.

3 (f) "General price level" means the annual average of the 12
4 monthly values for the United States ~~consumer price index~~ **CONSUMER**
5 **PRICE INDEX** for all urban consumers as defined and officially
6 reported by the United States ~~department~~ **DEPARTMENT** of labor,
7 ~~bureau~~ **LABOR, BUREAU** of labor statistics. **LABOR STATISTICS.**

8 (g) For taxes levied before 1995, "losses" means a decrease in
9 value caused by the removal or destruction of real or personal
10 property and the value of property taxed in the immediately
11 preceding year that has been exempted or removed from the
12 assessment unit's assessment roll.

13 (h) For taxes levied after 1994, "losses" means, except as
14 provided in subdivision (i), all of the following:

15 (i) Property that has been destroyed or removed. For purposes
16 of determining the taxable value of property under section 27a, the
17 value of property destroyed or removed is the product of the true
18 cash value of that property multiplied by a fraction, the numerator
19 of which is the taxable value of that property in the immediately
20 preceding year and the denominator of which is the true cash value
21 of that property in the immediately preceding year.

22 (ii) Property that was subject to ad valorem taxation under
23 this act in the immediately preceding year that is now exempt from
24 ad valorem taxation under this act. For purposes of determining the
25 taxable value of property under section 27a, the value of property
26 exempted from ad valorem taxation under this act is the amount
27 exempted.

1 (iii) Prior to December 31, 2013, an adjustment in value, if
2 any, because of a decrease in the property's occupancy rate, to the
3 extent provided by law. For purposes of determining the taxable
4 value of real property under section 27a, the value of a loss for a
5 decrease in the property's occupancy rate is the product of the
6 decrease in the true cash value of the property attributable to the
7 decreased occupancy rate multiplied by a fraction, the numerator of
8 which is the taxable value of the property in the immediately
9 preceding year and the denominator of which is the true cash value
10 of the property in the immediately preceding year.

11 (iv) A decrease in taxable value attributable to environmental
12 contamination existing on the immediately preceding tax day. The
13 department of environmental quality shall determine the degree to
14 which environmental contamination limits the use of property based
15 on information available in existing department of environmental
16 quality records or information made available to the department of
17 environmental quality if the appropriate assessing officer for a
18 local tax collecting unit requests that determination. The
19 department of environmental quality's determination of the degree
20 to which environmental contamination limits the use of property
21 shall be based on the criteria established for the categories set
22 forth in section 20120a(1) of the natural resources and
23 environmental protection act, 1994 PA 451, MCL 324.20120a. The
24 decrease in taxable value attributable to the contamination is the
25 decrease in true cash value attributable to the contamination
26 multiplied by a fraction, the numerator of which is the taxable
27 value of the property had it not been contaminated and the

1 denominator of which is the true cash value of the property had it
2 not been contaminated.

3 (i) For taxes levied after 1994, losses do not include
4 decreased value attributable to either of the following:

5 (i) Platting, splits, or combinations of property.

6 (ii) A change in the zoning of property.

7 (j) "New construction and improvements" means additions less
8 losses.

9 (k) "Current year" means the year for which the millage
10 limitation is being calculated.

11 (l) "Inflation rate" means the ratio of the general price
12 level for the state fiscal year ending in the calendar year
13 immediately preceding the current year divided by the general price
14 level for the state fiscal year ending in the calendar year before
15 the year immediately preceding the current year.

16 (2) On or before the first Monday in May of each year, the
17 assessing officer of each township or city shall tabulate the
18 tentative taxable value as approved by the local board of review
19 and as modified by county equalization for each classification of
20 property that is separately equalized for each unit of local
21 government and provide the tabulated tentative taxable values to
22 the county equalization director. The tabulation by the assessing
23 officer shall contain additions and losses for each classification
24 of property that is separately equalized for each unit of local
25 government or part of a unit of local government in the township or
26 city. If as a result of state equalization the taxable value of
27 property changes, the assessing officer of each township or city

1 shall revise the calculations required by this subsection on or
2 before the Friday following the fourth Monday in May. The county
3 equalization director shall compute these amounts and the current
4 and immediately preceding year's taxable values for each
5 classification of property that is separately equalized for each
6 unit of local government that levies taxes under this act within
7 the boundary of the county. The county equalization director shall
8 cooperate with equalization directors of neighboring counties, as
9 necessary, to make the computation for units of local government
10 located in more than 1 county. The county equalization director
11 shall calculate the millage reduction fraction for each unit of
12 local government in the county for the current year. The financial
13 officer for each taxing jurisdiction shall calculate the compounded
14 millage reduction fractions beginning in 1980 resulting from the
15 multiplication of successive millage reduction fractions and shall
16 recognize a local voter action to increase the compounded millage
17 reduction fraction to a maximum of 1 as a new beginning fraction.
18 Upon request of the superintendent of the intermediate school
19 district, the county equalization director shall transmit the
20 complete computations of the taxable values to the superintendent
21 of the intermediate school district within that county. At the
22 request of the presidents of community colleges, the county
23 equalization director shall transmit the complete computations of
24 the taxable values to the presidents of community colleges within
25 the county.

26 (3) On or before the first Monday in June of each year, the
27 county equalization director shall deliver the statement of the

1 computations signed by the county equalization director to the
2 county treasurer.

3 (4) On or before the second Monday in June of each year, the
4 treasurer of each county shall certify the immediately preceding
5 year's taxable values, the current year's taxable values, the
6 amount of additions and losses for the current year, and the
7 current year's millage reduction fraction for each unit of local
8 government that levies a property tax in the county.

9 (5) The financial officer of each unit of local government
10 shall make the computation of the tax rate using the data certified
11 by the county treasurer and the state tax commission. At the annual
12 session in October, or, for a county or local tax collecting unit
13 that approves under section 44a(2) the accelerated collection in a
14 summer property tax levy of a millage that had been previously
15 billed and collected as in a preceding tax year as part of the
16 winter property tax levy, before a special meeting held before the
17 annual levy on July 1, the county board of commissioners shall not
18 authorize the levy of a tax unless the governing body of the taxing
19 jurisdiction has certified that the requested millage has been
20 reduced, if necessary, in compliance with section 31 of article IX
21 of the state constitution of 1963.

22 (6) The number of mills permitted to be levied in a tax year
23 is limited as provided in this section pursuant to section 31 of
24 article IX of the state constitution of 1963. A unit of local
25 government shall not levy a tax rate greater than the rate
26 determined by reducing its maximum rate or rates authorized by law
27 or charter by a millage reduction fraction as provided in this

1 section without voter approval.

2 (7) A millage reduction fraction shall be determined for each
3 year for each local unit of government. For ad valorem property
4 taxes that became a lien before January 1, 1983, the numerator of
5 the fraction shall be the total state equalized valuation for the
6 immediately preceding year multiplied by the inflation rate and the
7 denominator of the fraction shall be the total state equalized
8 valuation for the current year minus new construction and
9 improvements. For ad valorem property taxes that become a lien
10 after December 31, 1982 and through December 31, 1994, the
11 numerator of the fraction shall be the product of the difference
12 between the total state equalized valuation for the immediately
13 preceding year minus losses multiplied by the inflation rate and
14 the denominator of the fraction shall be the total state equalized
15 valuation for the current year minus additions. For ad valorem
16 property taxes that are levied after December 31, 1994, the
17 numerator of the fraction shall be the product of the difference
18 between the total taxable value for the immediately preceding year
19 minus losses multiplied by the inflation rate and the denominator
20 of the fraction shall be the total taxable value for the current
21 year minus additions. For each year after 1993, a millage reduction
22 fraction shall not exceed 1.

23 (8) The compounded millage reduction fraction shall be
24 calculated by multiplying the local unit's previous year's
25 compounded millage reduction fraction by the current year's millage
26 reduction fraction. The compounded millage reduction fraction for
27 the year shall be multiplied by the maximum millage rate authorized

1 by law or charter for the unit of local government for the year,
2 except as provided by subsection (9). A compounded millage
3 reduction fraction shall not exceed 1.

4 (9) The millage reduction shall be determined separately for
5 authorized millage approved by the voters. The limitation on
6 millage authorized by the voters on or before April 30 of a year
7 shall be calculated beginning with the millage reduction fraction
8 for that year. Millage authorized by the voters after April 30
9 shall not be subject to a millage reduction until the year
10 following the voter authorization which shall be calculated
11 beginning with the millage reduction fraction for the year
12 following the authorization. The first millage reduction fraction
13 used in calculating the limitation on millage approved by the
14 voters after January 1, 1979 shall not exceed 1.

15 (10) A millage reduction fraction shall be applied separately
16 to the aggregate maximum millage rate authorized by a charter and
17 to each maximum millage rate authorized by state law for a specific
18 purpose.

19 (11) A unit of local government may submit to the voters for
20 their approval the levy in that year of a tax rate in excess of the
21 limit set by this section. The ballot question shall ask the voters
22 to approve the levy of a specific number of mills in excess of the
23 limit. The provisions of this section do not allow the levy of a
24 millage rate in excess of the maximum rate authorized by law or
25 charter. If the authorization to levy millage expires after 1993
26 and a local governmental unit is asking voters to renew the
27 authorization to levy the millage, the ballot question shall ask

1 for renewed authorization for the number of expiring mills as
2 reduced by the millage reduction required by this section. If the
3 election occurs before June 1 of a year, the millage reduction is
4 based on the immediately preceding year's millage reduction
5 applicable to that millage. If the election occurs after May 31 of
6 a year, the millage reduction shall be based on that year's millage
7 reduction applicable to that millage had it not expired.

8 (12) A reduction or limitation under this section shall not be
9 applied to taxes imposed for the payment of principal and interest
10 on bonds or other evidence of indebtedness or for the payment of
11 assessments or contract obligations in anticipation of which bonds
12 are issued that were authorized before December 23, 1978, as
13 provided by section 4 of chapter I of former 1943 PA 202, or to
14 taxes imposed for the payment of principal and interest on bonds or
15 other evidence of indebtedness or for the payment of assessments or
16 contract obligations in anticipation of which bonds are issued that
17 are approved by the voters after December 22, 1978.

18 (13) If it is determined subsequent to the levy of a tax that
19 an incorrect millage reduction fraction has been applied, the
20 amount of additional tax revenue or the shortage of tax revenue
21 shall be deducted from or added to the next regular tax levy for
22 that unit of local government after the determination of the
23 authorized rate pursuant to this section.

24 (14) If as a result of an appeal of county equalization or
25 state equalization the taxable value of a unit of local government
26 changes, the millage reduction fraction for the year shall be
27 recalculated. The financial officer shall effectuate an addition or

1 reduction of tax revenue in the same manner as prescribed in
2 subsection (13).

3 (15) The fractions calculated pursuant to this section shall
4 be rounded to 4 decimal places, except that the inflation rate
5 shall be computed by the state tax commission and shall be rounded
6 to 3 decimal places. The state tax commission shall publish the
7 inflation rate before March 1 of each year.

8 (16) Beginning with taxes levied in 1994, the millage
9 reduction required by section 31 of article IX of the state
10 constitution of 1963 shall permanently reduce the maximum rate or
11 rates authorized by law or charter. The reduced maximum authorized
12 rate or rates for 1994 shall equal the product of the maximum rate
13 or rates authorized by law or charter before application of this
14 section multiplied by the compounded millage reduction applicable
15 to that millage in 1994 pursuant to subsections (8) to (12). The
16 reduced maximum authorized rate or rates for 1995 and each year
17 after 1995 shall equal the product of the immediately preceding
18 year's reduced maximum authorized rate or rates multiplied by the
19 current year's millage reduction fraction and shall be adjusted for
20 millage for which authorization has expired and new authorized
21 millage approved by the voters pursuant to subsections (8) to (12).

22 Enacting section 1. This amendatory act does not take effect
23 unless House Bill No. 5143 of the 99th Legislature is enacted into
24 law.
