## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 50. (1) The department shall administer this act and may promulgate rules for its implementation and enforcement, or adopt revisions of standards adopted by reference in this act pursuant to UNDER the administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to 24.328.

- (2) The following standards are incorporated by reference:
