A bill to amend 2006 PA 110, entitled "Michigan zoning enabling act,"

by amending section 206 (MCL 125.3206), as amended by 2007 PA 219.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 206. (1) Except as otherwise—provided in subsection (2),
  a state licensed residential facility shall be considered EACH OF
  THE FOLLOWING IS a residential use of property for the purposes of
  zoning and a permitted use in all residential zones and is not
  subject to a special use or conditional use permit or procedure
  different from those required for other dwellings of similar
  density in the same zone: -
  - (i) A STATE LICENSED RESIDENTIAL FACILITY.

- 9 (9) The requirements of this section shall not prevent THIS

- 11 special use permit, conditional use permit, or other similar permit
- 12 to a licensed or registered group child care home that does not

- 14 (10) The distances required under subsection (4)(a) shall be

- 19 Enacting section 1. This amendatory act takes effect 90 days
- 20 after the date it is enacted into law.
- 21 Enacting section 2. This amendatory act does not take effect
- 22 unless House Bill No. 5505 of the 99th Legislature is enacted into
- 23 law.
