## SENATE BILL NO. 357

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998,"

(MCL 436.1101 to 436.2303) by adding section 609c.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 609C. (1) A MANUFACTURER THAT SELLS DIRECT TO A RETAILER
- 2 AS PROVIDED UNDER SECTION 203(19) OR A WHOLESALER MAY REFUND TO A
- 3 RETAILER THE AMOUNT THE RETAILER PAID FOR BEER OR WINE, AS
- 4 APPLICABLE, OR A MANUFACTURER THAT SELLS DIRECT TO A RETAILER AS
- 5 PROVIDED UNDER SECTION 203(19) OR A WHOLESALER MAY REPLACE THAT
- 6 BEER OR WINE FOR ANY OF THE FOLLOWING REASONS:
- 7 (A) THE BEER OR WINE IS OUTDATED.
- 8 (B) THE BEER OR WINE IS DEFECTIVE.
- 9 (C) AN ERROR IN THE BEER OR WINE DELIVERED.

- (D) THE BEER OR WINE MAY NO LONGER BE LAWFULLY SOLD. 1
- (E) THE TERMINATION OF THE RETAILER'S BUSINESS. 2
- 3 (F) THE FORMULA, PROOF, LABEL, OR CONTAINER OF THE BEER OR
- 4 WINE IS CHANGED.
- (G) THE BEER OR WINE IS DISCONTINUED. 5
- (H) THE RETAILER IS ONLY OPEN A PORTION OF THE YEAR AND THE 6
- BEER OR WINE IS LIKELY TO SPOIL DURING THE OFF-SEASON. 7
- (2) IF BEER IS WITHIN 30 DAYS OF ITS OUT-OF-DATE CODE, A 8
- MANUFACTURER THAT SELLS DIRECT TO A RETAILER AS PROVIDED UNDER 9
- SECTION 203(19) OR A WHOLESALER MAY REFUND TO A RETAILER THE AMOUNT 10
- 11 THE RETAILER PAID FOR THE BEER.
- 12 (3) A MANUFACTURER THAT SELLS DIRECT TO A RETAILER AS PROVIDED
- UNDER SECTION 203(19) OR A WHOLESALER MAY ONLY ISSUE A REFUND OR 13
- REPLACEMENT UNDER THIS SECTION FOR BEER OR WINE THAT THE 14
- MANUFACTURER OR WHOLESALER SOLD TO THE RETAILER. 15
- 16 Enacting section 1. This amendatory act takes effect 90 days
- after the date it is enacted into law. 17
