A bill to amend 2016 PA 470, entitled

"Michigan historical center act,"

by amending the title and sections 1, 2, 3, 7, and 8 (MCL 399.801, 399.802, 399.803, 399.807, and 399.808).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SENATE BILL No. 564

An act to create the Michigan historical HISTORY center; to prescribe the authority of the center; to provide for the archives of Michigan and the Michigan historical HISTORY museum to be under the control and supervision of the center; to provide stewardship for the museum and archival collection of this state; to provide for the management of state and local government records of archival value; to prescribe the powers and duties of certain state

- 1 and local agencies and officials; and to repeal acts and parts of
- 2 acts.
- 3 Sec. 1. This act shall be known and may be cited as the
- 4 "Michigan historical HISTORY center act".
- 5 Sec. 2. As used in this act:
- 6 (a) "Archives" means the archives of Michigan.
- 7 (b) "Center" means the Michigan historical HISTORY center.
- 8 (c) "Commission" means the Michigan historical commission
- 9 created in **SECTION 3 OF** the Michigan historical commission act,
- 10 2016 PA 469, MCL 399.833.
- (d) "Department" means the department of natural resources.
- 12 (e) "Director" means the director of the department.
- 13 (f) "Museum" means the Michigan historical HISTORY museum.
- 14 (g) "Operations fund" means the Michigan historical HISTORY
- 15 center operations fund created in section 8.
- 16 (h) "Publications fund" means the Michigan heritage
- 17 publications fund created in section 5.
- 18 (i) "Record" means any of the following:
- 19 (i) A document, paper, book, letter, or writing, including a
- 20 document, paper, book, letter, or writing prepared by handwriting,
- 21 typewriting, printing, photostating, photocopying, or electronic
- 22 medium.
- 23 (ii) A photograph.
- **24** (*iii*) A film.
- 25 (iv) A map.
- 26 (v) A magnetic or paper tape.
- (vi) A microform.

- 1 (vii) A magnetic or punch card.
- 2 (viii) A disc, drum, sound, or video recording.
- 3 (ix) An electronic data processing material.
- 4 (x) Recorded information in any electronic or digital file
- 5 format, including individual letters, words, pictures, sounds,
- 6 impulses, or symbols.
- 7 (xi) A combination of items listed in subparagraphs (i) to
- 8 (x), regardless of physical form or characteristics.
- 9 (j) "Rule" means a rule promulgated pursuant to the
- 10 administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to
- **11** 24.328.
- 12 (k) "Store" means the retail store operated by the center.
- Sec. 3. (1) The Michigan historical HISTORY center is
- 14 established in the department.
- 15 (2) The archives of Michigan and the Michigan historical
- 16 HISTORY museum shall be operated under the control and supervision
- 17 of the center.
- 18 (3) Using modern professional practices, the center shall do
- 19 all of the following:
- 20 (a) Advise the department on history policies and programs and
- 21 serve as a forum for citizen concerns and input.
- 22 (b) Collect, provide stewardship for, and interpret materials,
- 23 including, but not limited to, archival records in all available
- 24 media, artifacts, oral histories, and published family history
- 25 references, that document and illustrate the history of this state
- 26 and its people. The center shall make these materials available to
- 27 the public in a manner consistent with their preservation for

- 1 future generations, using techniques that include, but are not
- 2 limited to, museum exhibits, historical markers, public programs,
- 3 public research facilities, and online materials.
- 4 (c) Create Michigan-focused educational programs and materials
- 5 that reinforce adopted state educational standards.
- 6 (d) Provide professional assistance to other state and local
- 7 government agencies related to records designated for preservation
- 8 by approved records retention schedules.
- 9 (e) Use its resources to support heritage tourism and
- 10 community development in this state.
- 11 (f) Represent this state in its partnership with the Thunder
- 12 Bay National Marine Sanctuary and Underwater Preserve.
- 13 (g) Provide professional expertise and leadership for the
- 14 preservation and interpretation of history on state lands.
- 15 (4) Funds MONEY collected by the center for historical
- 16 markers, document reproduction and services, conferences,
- 17 admissions, workshops, training classes, and the use of specialized
- 18 equipment, facilities, exhibits, collections, and software shall be
- 19 used for expenses necessary to provide the required services.
- 20 FORWARDED TO THE STATE TREASURER FOR DEPOSIT INTO THE OPERATIONS
- 21 FUND. Subject to the annual appropriations process, the center may
- 22 charge reasonable fees for admissions and other services described
- 23 in this subsection. FEES COLLECTED UNDER THIS SUBSECTION SHALL BE
- 24 FORWARDED TO THE STATE TREASURER FOR DEPOSIT INTO THE OPERATIONS
- 25 FUND.
- 26 (5) The center may accept gifts and bequests, including
- 27 tangible and intangible property, for the furtherance of its

- 1 authorized purposes.
- 2 (6) Money collected under this section SUBSECTION shall be
- 3 forwarded to the state treasurer for deposit into the operations
- 4 fund.
- 5 Sec. 7. (1) Within the center, Michigan historical museum
- 6 responsibilities include, but are not limited to, accessioning and
- 7 deaccessioning artifacts that should be preserved for future
- 8 generations, providing stewardship for and access to those
- 9 artifacts, managing historic sites and museums that are owned by
- 10 the THIS state, creating interpretive plans and exhibits for its
- 11 managed sites and other sites within the department with the
- 12 exception of those operated by the Mackinac State Historic Parks,
- 13 and administering programs that support and extend the visitor
- 14 experience at its managed sites.
- 15 (2) Proceeds in excess of costs incurred in the conduct of
- 16 auctions, sales, or transfers of artifacts no longer considered
- 17 suitable for the collection of the museum may be expended upon
- 18 receipt for additional materials for the collection. The department
- 19 shall notify the chairpersons, vice-chairpersons, and minority
- 20 vice-chairpersons of the senate and house appropriations
- 21 subcommittees on natural resources 1 week prior to any auctions or
- 22 sales.
- 23 (3) Money collected under this section shall be forwarded to
- 24 the state treasurer for deposit into the operations fund.
- 25 Sec. 8. (1) The Michigan historical HISTORY center operations
- 26 fund is created within the state treasury.
- 27 (2) The state treasurer may receive money or other assets from

- 1 any source for deposit into the operations fund. The state
- 2 treasurer shall direct the investment of the operations fund. In
- 3 consultation with the department, the state treasurer may create
- 4 subaccounts within the operations fund. The state treasurer shall
- 5 credit to the operations fund interest and earnings from operations
- 6 fund investments.
- 7 (3) Money in the operations fund at the close of the fiscal
- 8 year shall remain in the operations fund and shall not lapse to the
- 9 general fund.
- 10 (4) The department shall be the administrator of the
- 11 operations fund for auditing purposes.
- 12 (5) The department shall expend money in the operations fund,
- 13 upon appropriation, to do any of the following:
- 14 (a) Purchase artifacts for the collections of the center.
- 15 (b) Restore artifacts in the collections of the center.
- 16 (c) Advertise and pay for educational programs, special
- 17 exhibits, and special events, including performers, presented at
- 18 the center or another museum or historical facility operated by the
- 19 department.
- 20 (d) Provide free materials to school groups.
- (e) Purchase items offered for sale at the store.
- 22 (f) Pay for any other expense incurred by the center.
- 23 (G) IMPLEMENT THE GOVERNOR JOHN B. SWAINSON MICHIGAN
- 24 HISTORICAL MARKERS ACT, 1955 PA 10, MCL 399.151 TO 399.160.
- 25 (6) THE DEPARTMENT SHALL ANNUALLY PREPARE A REPORT CONTAINING
- 26 AN ACCOUNTING OF REVENUES AND EXPENDITURES FROM THE OPERATIONS FUND
- 27 FOR THE PREVIOUS FISCAL YEAR. THE REPORT SHALL INCLUDE INFORMATION

- 1 ABOUT THE LOCATION OF ANY MARKERS ERECTED DURING THE PREVIOUS
- 2 FISCAL YEAR. THIS REPORT SHALL BE PROVIDED TO THE SENATE AND HOUSE
- 3 OF REPRESENTATIVES APPROPRIATIONS COMMITTEES AND THE STANDING
- 4 COMMITTEES OF THE SENATE AND HOUSE OF REPRESENTATIVES WITH
- 5 JURISDICTION OVER ISSUES PERTAINING TO NATURAL RESOURCES AND THE
- 6 ENVIRONMENT.
- 7 Enacting section 1. This amendatory act takes effect 90 days
- 8 after the date it is enacted into law.
- 9 Enacting section 2. This amendatory act does not take effect
- 10 unless all of the following bills of the 99th Legislature are
- 11 enacted into law:
