SENATE BILL NO. 589

A bill to amend 1997 PA 55, entitled
"Electric patrol vehicle act,"
by amending sections 2, 4, 5, and 6 (MCL 257.1572, 257.1574, 257.1575, and 257.1576).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. As used in this act:
- 2 (a) "Electric patrol vehicle" means an electrically powered
- 3 motor vehicle designed to carry not more than 4 persons —at a
- 4 speed **OF** not more than 25 miles per hour , having not less than 4
- 5 wheels—and having an unloaded weight of not more than 1,300 pounds.
- 6 (b) "Political subdivision" means a village, city, township,
- 7 county, or a university of this state.
- 8 (C) "SIDEWALK" MEANS A PAVED PUBLIC SIDEWALK INTENDED FOR
- 9 PEDESTRIAN USE SITUATED OUTSIDE OF AND ADJACENT TO THE IMPROVED

- 1 PORTION OF A STREET OR HIGHWAY DESIGNED FOR VEHICULAR TRAVEL.
- 2 Sec. 4. Subject to section 5, a political subdivision may, by
- 3 ordinance, authorize law enforcement, emergency service, and
- 4 parking enforcement employees of the political subdivision to
- 5 operate an electric patrol vehicle on a street, or highway, OR
- 6 SIDEWALK within that political subdivision's boundaries.
- 7 Sec. 5. An electric patrol vehicle authorized under section 4
- 8 shall be limited as follows:
- 9 (a) To a street or highway with a posted speed limit of not
- 10 more than 25 miles per hour.
- 11 (b) To crossing a street or highway with a posted speed limit
- 12 of not more than 50 miles per hour.
- 13 (C) TO A SIDEWALK.
- Sec. 6. (1) Each EXCEPT AS PROVIDED IN [SUBSECTIONS] (2) [
 AND (3)] EACH
- 15 electric patrol vehicle authorized under section 4 shall have all
- 16 of the following equipment:
- 17 (a) Brakes adequate to control the movement of and to stop and
- 18 hold the vehicle.
- 19 (b) Not less than 2 head lamps that enable the operator of the
- 20 vehicle to see a person not less than 100 feet to the front of the
- 21 vehicle.
- (c) Not less than 2 rear lamps that comply with section 697 of
- 23 the Michigan vehicle code, 1949 PA 300, MCL 257.697.
- 24 (d) A windshield of safety glass as defined in section 711 of
- 25 the Michigan vehicle code, 1949 PA 300, MCL 257.711.
- 26 (e) A horn as defined in section 706(a) of the Michigan
- 27 vehicle code, 1949 PA 300, MCL 257.706.

- 1 (f) Safety belts designed and installed with brackets and of
- 2 sufficient strength to hold a passenger during a collision.
- 3 (g) A parking brake sufficient to hold the vehicle in a
- 4 stopped position.
- 5 (h) Reflectors that reflect an amber or red color as required
- 6 for motor vehicles by section 690 of the Michigan vehicle code,
- 7 1949 PA 300, MCL 257.690.
- 8 (2) [EXCEPT AS PROVIDED IN SUBSECTION (3), AN] ELECTRIC PATROL VEHICLE THAT HAS 3 WHEELS OR LESS SHALL
- 9 HAVE ALL OF THE FOLLOWING EQUIPMENT:
- 10 (A) BRAKES ADEQUATE TO CONTROL THE MOVEMENT OF AND TO STOP AND
- 11 HOLD THE VEHICLE.
- 12 (B) ONE OR 2 HEADLAMPS THAT ENABLE THE OPERATOR OF THE VEHICLE
- 13 TO SEE A PERSON NOT LESS THAN 100 FEET TO THE FRONT OF THE VEHICLE.
- 14 (C) AT LEAST 1 REAR LAMP THAT COMPLIES WITH SECTION 697 OF THE
- 15 MICHIGAN VEHICLE CODE, 1949 PA 300, MCL 257.697.
- 16 (D) A HORN AS DEFINED IN SECTION 706(A) OF THE MICHIGAN
- 17 VEHICLE CODE, 1949 PA 300, MCL 257.706.
- 18 (E) A PARKING BRAKE SUFFICIENT TO HOLD THE VEHICLE IN A
- 19 STOPPED POSITION.
- 20 (F) REFLECTORS THAT REFLECT AN AMBER OR RED COLOR AS REQUIRED
- 21 FOR MOTOR VEHICLES BY SECTION 690 OF THE MICHIGAN VEHICLE CODE,
- 22 1949 PA 300, MCL 257.690.
 - [(3) A POLITICAL SUBDIVISION MAY, BY ORDINANCE, EXEMPT AN ELECTRIC PATROL VEHICLE FROM SUBSECTION (1) OR (2).]
- 23 Enacting section 1. This amendatory act takes effect 90 days
- 24 after the date it is enacted into law.
