## HOUSE SUBSTITUTE FOR SENATE BILL NO. 634

A bill to amend 1978 PA 368, entitled "Public health code,"
by amending section 18223 (MCL 333.18223), as amended by 2014 PA 385.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 18223. (1) The department, in consultation with the
- 2 board, shall promulgate rules requiring that to be granted a
- 3 license under this part, except as provided in subsection (2), an
- 4 individual must meet both of the following requirements:
- 5 (a) Have been granted a doctoral degree in psychology, or a
- 6 doctoral degree in a closely related field, from a doctoral degree
- 7 program that meets both ALL of the following requirements:
- 8 (i) Is offered by a regionally accredited or other college,

- 1 university, or institution approved by the board, which program
- 2 included AND INCLUDES education and training appropriate to the
- 3 practice of psychology.
- 4 (ii) Has obtained the association ASSOCIATION of state STATE
- 5 and provincial psychology boards' PROVINCIAL PSYCHOLOGY BOARDS'
- 6 national register designation, has been accredited by the American
- 7 psychological association PSYCHOLOGICAL ASSOCIATION or the Canadian
- 8 psychological association, PSYCHOLOGICAL ASSOCIATION, or has
- 9 obtained a similar designation from or been accredited by an entity
- 10 approved by the board. For purposes of the requirement added by
- 11 2010 PA 121, HOWEVER, a program that is in the process of obtaining
- 12 the designation or becoming accredited as required in this sub-
- 13 subparagraph SUBPARAGRAPH before August 1, 2011, and that obtains
- 14 the designation or becomes accredited on or before August 31, 2020,
- 15 meets the requirements of this sub-subparagraph.SUBPARAGRAPH.
- 16 (b) Have not less than 1 year of postdoctoral experience in
- 17 the practice of psychology in an organized health care setting or
- 18 other arrangement, as established by the board.
- 19 (2) In addition to section 16182, the board shall grant a
- 20 limited license to an individual granted a master's degree in
- 21 psychology from a regionally accredited college, or university, or
- 22 institution approved by the board, if the individual has education,
- 23 training, and experience appropriate to the practice of psychology,
- 24 as established by the board. AN INDIVIDUAL WHO APPLIES FOR AN
- 25 INITIAL LIMITED LICENSE UNDER THIS SUBSECTION BEFORE MARCH 31, 2018
- 26 IS NOT REQUIRED TO TAKE AN EXAMINATION THAT IS APPROVED BY THE
- 27 BOARD TO BE GRANTED A LIMITED LICENSE UNDER THIS PART IF THE

- 1 INDIVIDUAL WAS GRANTED A MASTER'S DEGREE IN PSYCHOLOGY AFTER
- 2 JANUARY 1, 2007 BUT BEFORE JUNE 30, 2010 FROM THE COLLEGE,
- 3 UNIVERSITY, OR INSTITUTION DESCRIBED IN THIS SUBSECTION, THE
- 4 INDIVIDUAL HAS CONTINUOUSLY HELD THE TEMPORARY LICENSE DESCRIBED IN
- 5 THIS SECTION SINCE IT WAS INITIALLY GRANTED BY THE BOARD, AND THE
- 6 DISCIPLINARY SUBCOMMITTEE HAS NOT IMPOSED A SANCTION AGAINST THE
- 7 INDIVIDUAL WHILE HOLDING THE TEMPORARY LICENSE DESCRIBED IN THIS
- 8 SECTION. Except for duties performed as an employee of a
- 9 governmental entity or of a nonprofit organization serving
- 10 benevolent and charitable purposes, the board shall place 2
- 11 limitations on a license granted to an individual under this
- 12 subsection. The limitations must require supervision by a
- 13 psychologist who has a license other than a limited license and
- 14 must prohibit advertising or other representation to the public
- 15 that will lead the public to believe the individual is engaging in
- 16 the practice of psychology. A limited license granted under this
- 17 subsection is renewable <del>pursuant to UNDER</del> part 161. An individual
- 18 WHO IS applying for a limited license pursuant to UNDER this
- 19 subsection must have 1 year of supervised postgraduate experience
- 20 in an organized health care setting or other arrangement, as
- 21 established by the board. The individual must be supervised by a
- 22 psychologist who has a license other than a limited license, or if
- 23 a psychologist who has a license other than a limited license is
- 24 not available, by a psychologist who has at least a master's degree
- 25 in psychology and at least 3 years of experience in the practice of
- 26 psychology or by any other individual approved by the board.
- 27 (3) The board shall issue GRANT a temporary license to the AN

- 1 individual DESCRIBED IN SUBSECTION (2) for the purpose of obtaining
- 2 the 1 year of postgraduate experience DESCRIBED IN THAT SUBSECTION.
- BEGINNING ON MARCH 31, 2018, A TEMPORARY LICENSE GRANTED UNDER THIS 3
- 4 SUBSECTION IS VALID FOR 24 MONTHS AND MAY BE RENEWED FOR 1
- ADDITIONAL 24-MONTH TERM. IF AN INDIVIDUAL DESCRIBED IN SUBSECTION 5
- (2) WAS GRANTED A TEMPORARY LICENSE BY THE BOARD BEFORE MARCH 31,
- 2018, HIS OR HER TEMPORARY LICENSE MAY BE RENEWED FOR 1 ADDITIONAL 7
- 8 24-MONTH TERM.
- (4) THE BOARD SHALL GRANT A TEMPORARY LICENSE TO AN INDIVIDUAL 9
- WHO IS ENROLLED IN A DOCTORAL DEGREE PROGRAM THAT MEETS THE 10
- 11 REQUIREMENTS OF SUBSECTION (1). BEGINNING ON MARCH 31, 2018, A
- 12 TEMPORARY LICENSE GRANTED UNDER THIS SUBSECTION IS VALID FOR 24
- MONTHS AND MAY BE RENEWED FOR 3 ADDITIONAL 24-MONTH TERMS. IF AN 13
- INDIVIDUAL ENROLLED IN A DOCTORAL PROGRAM THAT MEETS THE 14
- REQUIREMENTS OF SUBSECTION (1) WAS GRANTED A TEMPORARY LICENSE BY 15
- 16 THE BOARD BEFORE MARCH 31, 2018, HIS OR HER TEMPORARY LICENSE MAY
- 17 BE RENEWED FOR 3 ADDITIONAL 24-MONTH TERMS.
