SUBSTITUTE FOR

SENATE BILL NO. 337

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 136.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 136. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A
- 2 PERSON SHALL NOT KNOWINGLY PERFORM A SURGICAL OPERATION TO
- 3 CIRCUMCISE, INCISE, EXCISE, OR INFIBULATE ALL OR ANY PART OF THE
- 4 LABIA MAJORA OR LABIA MINORA, CLITORIS, OR CONTIGUOUSLY SURROUNDING
- 5 TISSUE ON ANOTHER PERSON WHO IS LESS THAN 18 YEARS OF AGE,
- 6 REGARDLESS OF WHETHER THE SURGICAL OPERATION CAUSES PHYSICAL
- 7 DEFORMITY, RESIDUAL PAIN, OR LOSS OF SENSATION.
- 8 (2) A PERSON WHO VIOLATES SUBSECTION (1) IS GUILTY OF A FELONY
- 9 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 15 YEARS.
- 10 (3) A SURGICAL OPERATION IS NOT A VIOLATION OF THIS SECTION IF

- 1 EITHER OF THE FOLLOWING CONDITIONS APPLIES:
- 2 (A) IT IS NECESSARY TO THE HEALTH OF THE PERSON ON WHOM IT IS
- 3 PERFORMED, AND IT IS PERFORMED BY A LICENSED MEDICAL PRACTITIONER.
- 4 (B) IT IS PERFORMED ON A PERSON IN LABOR OR WHO HAS JUST GIVEN
- 5 BIRTH AND IS PERFORMED FOR MEDICAL PURPOSES CONNECTED WITH THAT
- 6 LABOR OR BIRTH BY A LICENSED MEDICAL PRACTITIONER, MIDWIFE, OR
- 7 PERSON IN TRAINING TO BECOME A LICENSED MEDICAL PRACTITIONER.
- 8 (4) IN A PROSECUTION UNDER THIS SECTION, IT IS NOT A DEFENSE
- 9 THAT THE DEFENDANT BELIEVED EITHER OF THE FOLLOWING CONCERNING THE
- 10 SURGICAL OPERATION:
- 11 (A) THAT THE PERSON ON WHOM THE SURGICAL OPERATION WAS
- 12 PERFORMED OR WAS TO BE PERFORMED WAS 18 YEARS OF AGE OR OLDER.
- 13 (B) THAT THE SURGICAL OPERATION IS OR WAS REQUIRED AS A MATTER
- 14 OF CUSTOM OR RITUAL.
- 15 (5) AS USED IN THIS SECTION:
- 16 (A) "LICENSED MEDICAL PRACTITIONER" MEANS A MEDICAL PHYSICIAN
- 17 OR OSTEOPATHIC PHYSICIAN WHO IS LICENSED UNDER ARTICLE 15 OF THE
- 18 PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.16101 TO 333.18838.
- 19 (B) "LICENSED MIDWIFE" MEANS A MIDWIFE LICENSED UNDER ARTICLE
- 20 15 OF THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.16101 TO
- 21 333.18838.
- 22 (C) "PERSON IN TRAINING" MEANS AN INDIVIDUAL ACTING UNDER THE
- 23 DELEGATORY AUTHORITY AND SUPERVISION OF A PHYSICIAN UNDER SECTION
- 24 16215(2) OF THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.16215.
- 25 PERSON IN TRAINING INCLUDES, BUT IS NOT LIMITED TO, AN INDIVIDUAL
- 26 DESCRIBED IN SECTION 16215(3) OF THE PUBLIC HEALTH CODE, 1978 PA
- 27 368, MCL 333.16215, BUT DOES NOT INCLUDE AN INDIVIDUAL WHOSE

- LICENSE HAS BEEN SUSPENDED UNDER ARTICLE 15. 1
- Enacting section 1. This amendatory act takes effect 90 days 2
- 3 after the date it is enacted into law.
