SUBSTITUTE FOR SENATE BILL NO. 358

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998,"

(MCL 436.1101 to 436.2303) by adding section 610a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 610A. (1) SUBJECT TO SUBSECTION (2), A MANUFACTURER,
- 2 MIXED SPIRIT DRINK MANUFACTURER, WAREHOUSER, WHOLESALER, OUTSTATE
- 3 SELLER OF BEER, OUTSTATE SELLER OF MIXED SPIRIT DRINK, OR VENDOR OF
- 4 SPIRITS MAY PROVIDE TO A RETAILER SIGNS THAT PROMOTE THE BRANDS AND
- 5 PRICES OF ALCOHOLIC LIQUOR, INCLUDING SPECIAL EVENT PRICING.
- 6 (2) ALL OF THE FOLLOWING APPLY TO A SIGN ALLOWED UNDER
- 7 SUBSECTION (1):
- 8 (A) THE SIGN MUST NOT BE ILLUMINATED.
- 9 (B) THE SIGN MUST NOT HAVE ANY USE BEYOND THE ACTUAL
- 10 ADVERTISING OF BRANDS, PRICES, AND EVENTS RELATED TO THE ALCOHOLIC
- 11 LIQUOR.

- 1 (C) THE SIGN MUST NOT INCLUDE THE NAME OF THE RETAILER.
- 2 (D) FOR A SIGN THAT IS LOCATED INSIDE THE RETAILER'S LICENSED
- 3 PREMISES, THE SIGN MUST NOT BE MORE THAN 3,500 SQUARE INCHES IN
- 4 DIMENSION.
- 5 (3) A RETAILER MAY USE AN ILLUMINATED SIGN TO PROMOTE THE
- 6 BRAND BUT NOT THE PRICE OF ALCOHOLIC LIQUOR. A MANUFACTURER, MIXED
- 7 SPIRIT DRINK MANUFACTURER, WAREHOUSER, WHOLESALER, OUTSTATE SELLER
- 8 OF BEER, OUTSTATE SELLER OF WINE, OUTSTATE SELLER OF MIXED SPIRIT
- 9 DRINK, OR VENDOR OF SPIRITS SHALL NOT PROVIDE TO A RETAILER A SIGN
- 10 DESCRIBED IN THIS SUBSECTION.
- 11 (4) THE SIGNS ALLOWED UNDER THIS SECTION ARE IN ADDITION TO
- 12 THE ADVERTISING ITEMS THAT A MANUFACTURER, MIXED SPIRIT DRINK
- 13 MANUFACTURER, WAREHOUSER, WHOLESALER, OUTSTATE SELLER OF BEER,
- 14 OUTSTATE SELLER OF WINE, OUTSTATE SELLER OF MIXED SPIRIT DRINK, OR
- 15 VENDOR OF SPIRITS MAY PROVIDE ANOTHER LICENSEE UNDER SECTION
- 16 609(2).
- 17 Enacting section 1. This amendatory act takes effect 90 days
- 18 after the date it is enacted into law.
