## SUBSTITUTE FOR SENATE BILL NO. 545

A bill to amend 2000 PA 161, entitled "Michigan education savings program act,"

(MCL 390.1471 to 390.1486) by adding sections 21 and 22.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 21. (1) FROM THE INFORMATION RECEIVED FROM EACH PUBLIC
- 2 SCHOOL PURSUANT TO SECTION 1210 OF THE REVISED SCHOOL CODE, 1976 PA
- 3 451, MCL 380.1210, THE DEPARTMENT OF EDUCATION SHALL DETERMINE
- 4 WHICH SERVICES, COURSES, MATERIALS, AND ANY OTHER FEES AND COSTS
- 5 THAT ARE OFFERED BY EACH PUBLIC SCHOOL ARE ELIGIBLE SERVICES THAT
- 6 MAY BE PURCHASED USING AN ACCOUNT. CORE INSTRUCTIONAL COURSES ARE
- 7 NOT ELIGIBLE SERVICES THAT MAY BE PURCHASED USING AN ACCOUNT UNLESS
- 8 THE FOUNDATION ALLOWANCE CALCULATED UNDER SECTION 20 OF THE STATE
- 9 SCHOOL AID ACT OF 1979, 1979 PA 94, MCL 388.1620, AVAILABLE FOR

- 1 THAT STUDENT HAS BEEN EXHAUSTED. THE DEPARTMENT OF EDUCATION SHALL
- 2 DIVIDE THE SERVICES INTO 5 SEPARATE CATEGORIES AS FOLLOWS:
- 3 (A) CORE INSTRUCTIONAL COURSES.
- 4 (B) NONCORE INSTRUCTIONAL COURSES.
- 5 (C) EXTRACURRICULAR ACTIVITIES.
- 6 (D) SUPPORT ACTIVITIES.
- 7 (E) COURSE MATERIALS.
- 8 (2) EACH PUBLIC SCHOOL THAT COMPLIES WITH SECTION 1210 OF THE
- 9 REVISED SCHOOL CODE, 1976 PA 451, MCL 380.1210, IS ELIGIBLE TO
- 10 RECEIVE PAYMENTS FROM THE PROGRAM. THE DEPARTMENT MAY DESIGNATE
- 11 OTHER ORGANIZATIONS THAT PROVIDE CORE INSTRUCTIONAL COURSES AND
- 12 NONCORE INSTRUCTIONAL COURSES, EXTRACURRICULAR AND SUPPORT
- 13 ACTIVITIES, AND COURSE MATERIALS AS ELIGIBLE TO RECEIVE PAYMENTS
- 14 FROM THE PROGRAM.
- 15 SEC. 22. WITHIN 1 YEAR AFTER THE EFFECTIVE DATE OF THIS
- 16 SECTION, THE DEPARTMENT, IN CONSULTATION WITH THE DEPARTMENT OF
- 17 EDUCATION, SHALL ESTABLISH AND MAINTAIN AN INTERNET WEBSITE
- 18 DEDICATED TO THIS PROGRAM. THE WEBSITE SHALL SERVE AS THE PORTAL
- 19 FOR INFORMATION ABOUT THE ENHANCED MICHIGAN EDUCATION SAVINGS
- 20 ACCOUNTS AND THE SERVICES AND COURSES OFFERED BY EACH PUBLIC SCHOOL
- 21 AND ANY OTHER ORGANIZATION IN THIS STATE. THE WEBSITE SHALL INCLUDE
- 22 AT LEAST BOTH OF THE FOLLOWING:
- 23 (A) A BREAKDOWN OF THE MINIMUM REQUIREMENTS FOR ANNUAL COURSE
- 24 LOADS AND COURSE DESCRIPTIONS.
- 25 (B) A MECHANISM FOR THE ENROLLMENT OF STUDENTS INTO SERVICES
- 26 AND TO ALLOW FOR THE PAYMENT OF THOSE ELIGIBLE SERVICES FROM EACH
- 27 STUDENT'S ACCOUNT BY THE ACCOUNT OWNER.

- Enacting section 1. This amendatory act does not take effect 1
- unless Senate Bill No. 544 of the 99th Legislature is enacted into 2
- 3 law.
