## **SENATE BILL No. 560**

September 13, 2017, Introduced by Senator SCHMIDT and referred to the Committee on Outdoor Recreation and Tourism.

A bill to amend 2008 PA 288, entitled "Legal defense fund act," by amending section 11 (MCL 15.531).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 11. (1) The secretary of state shall make a statement or report required to be filed under this act available for public inspection and reproduction, commencing as soon as practicable, but not later than the third business day following the day on which it is received, during regular business hours of the filing official.

  The secretary of state shall also make the report or all of the contents of the report available to the public on the internet, without charge, as soon as practicable, at a single website

- 1 (2) A copy of a statement or part of a statement shall be

- 4 (6) The secretary of state shall determine whether a statement

- 5 filing is filed within the prescribed time regardless of when it is
- 6 actually delivered. Any other statement or report required to be
- 7 filed under this act that is postmarked by registered or certified
- 8 mail or sent by express mail or other overnight delivery service on
- 9 or before the deadline for filing is filed within the prescribed
- 10 time regardless of when it is actually delivered.
- 11 Enacting section 1. This amendatory act takes effect 90 days
- 12 after the date it is enacted into law.

- of the 99th Legislature is enacted into law.
