SUBSTITUTE FOR

SENATE BILL NO. 613

A bill to amend 2008 PA 23, entitled

"Enhanced driver license and enhanced official state personal identification card act,"

by amending section 4 (MCL 28.304).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 4. (1) The secretary of state may issue an enhanced
- 2 driver's license or enhanced official state personal identification
- 3 card to an applicant who provides satisfactory proof of his or her
- 4 full legal name, United States citizenship, identity, date of
- 5 birth, social security number, residence address, and a
- 6 photographic identity document. An applicant may choose to apply
- 7 for a standard driver license or standard official state personal
- 8 identification card or an enhanced driver license or enhanced state
- 9 personal identification card.
- 10 (2) An enhanced driver license or enhanced official state

- 1 personal identification card shall include reasonable security
- 2 measures to protect against unauthorized disclosure of personal
- 3 information regarding residents of this state that is contained in
- 4 the enhanced driver license or enhanced official state personal
- 5 identification card.
- 6 (3) An enhanced driver license or enhanced official state
- 7 personal identification card may include radio frequency
- 8 identification technology that is limited to a randomly assigned
- 9 number, which shall be encrypted if agreed to by the department of
- 10 homeland security, DEPARTMENT OF HOMELAND SECURITY, and does not
- 11 include biometric data. The secretary of state shall ensure that
- 12 the radio frequency identification technology is secure from
- 13 unauthorized data access and includes reasonable security measures
- 14 to protect against unauthorized disclosure of personal information.
- 15 An applicant shall be required to MUST sign a declaration
- 16 acknowledging his or her understanding of the radio frequency
- 17 identification technology before he or she is issued an enhanced
- 18 driver license or enhanced official state personal identification
- **19** card.
- 20 (4) The requirements of this act are in addition to the
- 21 requirements otherwise imposed on individuals who apply for a
- 22 standard driver license or standard official state personal
- 23 identification card.
- 24 (5) The holder of an enhanced driver license issued under this
- 25 act is subject to every licensing sanction provided under the
- 26 Michigan vehicle code, 1949 PA 300, MCL 257.1 to 257.923. As used
- 27 in this subsection, "licensing sanction" means the restriction,

- 1 suspension, revocation, or denial of a driver license; the addition
- 2 of points to a driving record; UNTIL OCTOBER 1, 2018, the
- 3 assessment of a driver responsibility fee; the assessment of a
- 4 civil fine or criminal penalty resulting from a conviction; a civil
- 5 infraction determination; the imposition of probationary terms and
- 6 conditions; or any other penalty provided under the Michigan
- 7 vehicle code, 1949 PA 300, MCL 257.1 to 257.923.
