## SUBSTITUTE FOR

## SENATE BILL NO. 1166

A bill to amend 1998 PA 58, entitled
"Michigan liquor control code of 1998,"
by amending section 111 (MCL 436.1111), as amended by 2010 PA 213.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 111. (1) "Person" means an individual, firm, partnership,
- 2 limited partnership, association, limited liability company, or
- 3 corporation.
- 4 (2) "Primary source of supply" means, in the case of domestic
- 5 spirits, the distiller, producer, owner of the commodity at the
- 6 time it becomes a marketable product, or bottler, or the exclusive
- 7 agent of any such person THE DISTILLER, PRODUCER, OWNER OF THE
- 8 COMMODITY AT THE TIME IT BECOMES A MARKETABLE PRODUCT, OR BOTTLER,
- 9 and, in the case of spirits imported into the United States, either
- 10 the foreign distiller, producer, owner of the bottler, or the prime

- 1 importer for, or the exclusive agent in the United States of, the
- 2 foreign distiller, producer, owner, or the bottler.
- 3 (3) "Professional account" means an account established for a
- 4 person by a class C licensee or tavern licensee whose major
- 5 business is the sale of food, by which the licensee extends credit
- 6 to the person for not more than 30 days.
- 7 (4) "Residence" means the premises in which a person resides
- 8 permanently.
- 9 (5) "RESTAURANT" MEANS A FOOD SERVICE ESTABLISHMENT DEFINED
- 10 AND LICENSED UNDER THE FOOD LAW, 2000 PA 92, MCL 289.1101 TO
- 11 289.8111. A RESTAURANT THAT DOES NOT HOLD A LICENSE ISSUED BY THE
- 12 COMMISSION UNDER THIS ACT SHALL NOT MANUFACTURE, MARKET, DELIVER,
- 13 OR SELL ALCOHOLIC LIQUOR IN THIS STATE.
- 14 (6) (5) "Retailer" means a person licensed by the commission
- 15 who sells to the consumer in accordance with rules promulgated by
- 16 the commission. Retailer includes a brewpub but does not include a
- 17 manufacturer or supplier, as defined in section 603, that is
- 18 allowed as a condition of its license to sell to consumers in this
- 19 state.
- 20 (7) (6)—"Sacramental wine" means wine containing not more than
- 21 24% of alcohol by volume which THAT is used for sacramental
- 22 purposes.
- 23 (8) (7) "Sale" includes the exchange, barter, traffic,
- 24 furnishing, DELIVERY, or giving away of alcoholic liquor. In the
- 25 case of a sale in which a shipment or delivery of alcoholic liquor
- 26 is made by a common or other carrier, the sale of the alcoholic
- 27 liquor is considered to be made in the county within which the

- 1 delivery of the alcoholic liquor is made by that carrier to the
- 2 consignee or his or her agent or employee, and venue for the
- 3 prosecution for that sale may be in the county or city where the
- 4 seller resides or from which the shipment is made or at the place
- 5 of delivery.
- 6 (9) <del>(8) "School" includes buildings used for school purposes</del>
- 7 to provide instruction to children in grades kindergarten through
- 8 12, when IF that instruction is provided by a public, private,
- 9 denominational, or parochial school, except those buildings used
- 10 primarily for adult education or college extension courses. School
- 11 does not include a proprietary trade or occupational school.
- 12 (10) "SHINER" MEANS AN UNLABELED, SEALED CONTAINER OF WINE,
- 13 INCLUDING A KEG, THAT IS SOLD BY A WINE MAKER, SMALL WINE MAKER, OR
- 14 OUT-OF-STATE ENTITY THAT IS THE SUBSTANTIAL EQUIVALENT OF A WINE
- 15 MAKER OR SMALL WINE MAKER TO ANOTHER WINE MAKER, SMALL WINE MAKER,
- 16 OR OUT-OF-STATE ENTITY THAT IS THE SUBSTANTIAL EQUIVALENT OF A WINE
- 17 MAKER OR SMALL WINE MAKER. THE PURCHASING WINE MAKER OR SMALL WINE
- 18 MAKER MUST ATTACH A LABEL TO THE CONTAINER USING EQUIPMENT OWNED OR
- 19 LEASED BY THE PURCHASING WINE MAKER OR SMALL WINE MAKER, REGISTER
- 20 THE WINE LABEL WITH THE COMMISSION, AND SELL IT AS PROVIDED FOR IN
- 21 THIS ACT.
- 22 (11) (9)—"Small distiller" means a manufacturer of spirits
- 23 annually manufacturing in Michigan THIS STATE not exceeding MORE
- 24 THAN 60,000 gallons of spirits, of all brands combined.
- 25 (12) (10) "Small wine maker" means a wine maker manufacturing
- 26 or bottling not more than 50,000 gallons of wine in 1 calendar
- 27 year. A SMALL WINE MAKER IS NOT REQUIRED TO BOTTLE WINE IT

## 1 MANUFACTURES.

- 2 (13) (11) "Special license" means a contract between the
- 3 commission and the special licensee granting authority to that
- 4 licensee to sell beer, wine, mixed spirit drink, or spirits. The
- 5 license shall MUST be granted only to such persons and such
- 6 organization and for such period of time as the commission shall
- 7 determine so long as **DETERMINES** IF the person or organization is
- 8 able to demonstrate an existence separate from an affiliated
- 9 umbrella organization. If such an existence is demonstrated, the
- 10 commission shall not deny a special license solely by the
- 11 applicant's affiliation with an organization that is also eligible
- 12 for a special license.
- 13 (14) (12) "Specially designated distributor" means, subject to
- 14 section 534, a person engaged in an established business licensed
- 15 by the commission to distribute spirits and mixed spirit drink in
- 16 the original package for the commission for consumption off the
- 17 premises.
- 18 (15) (13)—"Specially designated merchant" means a person to
- 19 whom the commission grants a license to sell beer or wine, or both,
- 20 at retail for consumption off the licensed premises.
- 21 (16) (14)—"Spirits" means a beverage that contains alcohol
- 22 obtained by distillation, mixed with potable water or other
- 23 substances, or both, in solution, and includes wine containing an
- 24 alcoholic content of more than 21% by volume, except sacramental
- 25 wine and mixed spirit drink.
- **26** (17) (15)—"State liquor store" means a store established by
- 27 the commission under this act for the sale of spirits in the

- 1 original package for consumption off the premises.
- 2 (18) (16) "Supplier of spirits" means a vendor of spirits, a
- 3 manufacturer of spirits, or a primary source of supply.
- 4 Enacting section 1. This amendatory act does not take effect
