## SUBSTITUTE FOR SENATE BILL NO. 826

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending sections 16265 and 17708 (MCL 333.16265 and 333.17708), section 17708 as amended by 2016 PA 499, and by adding section 16348a and part 186.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 16265. (1) An individual licensed under this article to
- 2 engage in the practice of chiropractic, dentistry, medicine,
- 3 optometry, osteopathic medicine and surgery, podiatric medicine and
- 4 surgery, psychology, or veterinary medicine, OR NATUROPATHIC
- 5 MEDICINE shall not use the terms "doctor" or "dr." in any written
- 6 or printed matter or display without adding thereto "of
- 7 chiropractic", "of dentistry", "of medicine", "of optometry", "of

- 1 osteopathic medicine and surgery", "of podiatric medicine and
- 2 surgery", "of psychology", "of veterinary medicine", "OF
- 3 NATUROPATHIC MEDICINE", or a similar term, respectively.
- 4 (2) An individual licensed under part 182 shall not use the
- 5 terms "doctor" or "dr." without having been granted a doctoral
- 6 degree in psychology from a regionally or nationally accredited
- 7 college or university.
- 8 SEC. 16348A. THE DEPARTMENT SHALL ANNUALLY ESTABLISH A
- 9 SCHEDULE OF FEES FOR AN INDIVIDUAL LICENSED OR SEEKING A LICENSE AS
- 10 A NATUROPATHIC PHYSICIAN UNDER PART 186 TO OFFSET THE DEPARTMENT'S
- 11 ADMINISTRATIVE EXPENSES UNDER THAT PART.
- Sec. 17708. (1) "Preceptor" means a pharmacist approved by the
- 13 board to direct the training of an intern in an approved pharmacy.
- 14 (2) "Prescriber" means a licensed dentist, a licensed doctor
- 15 of medicine, a licensed doctor of osteopathic medicine and surgery,
- 16 a licensed doctor of podiatric medicine and surgery, a licensed
- 17 physician's assistant, a licensed optometrist certified under part
- 18 174 to administer and prescribe therapeutic pharmaceutical agents,

- 18 (F) AN INDIVIDUAL WHO IS EDUCATED AND TRAINED IN NATUROPATHY
- 19 OR NATUROPATHIC HEALTH CARE AND PROVIDES NATUROPATHIC THERAPY
- 20 WITHIN THE SCOPE OF THAT EDUCATION AND TRAINING.
- 21 (G) AN INDIVIDUAL WHO IS EDUCATED AND TRAINED AS A NATUROPATH,
- 22 NATUROPATHIC PRACTITIONER, OR TRADITIONAL NATUROPATHIC PRACTITIONER
- 23 AND WHO PROVIDES NATUROPATHIC THERAPY WITHIN THE SCOPE OF THAT

- 18 SEC. 18631. EACH LICENSE GRANTED OR RENEWED UNDER THIS PART
- 19 EXPIRES 4 YEARS FOLLOWING THE DATE IT WAS GRANTED OR LAST RENEWED.
- 20 SEC. 18633. THIS PART DOES NOT REQUIRE NEW OR ADDITIONAL THIRD
- 21 PARTY REIMBURSEMENT OR MANDATED WORKER'S COMPENSATION BENEFITS FOR
- 22 SERVICES RENDERED BY AN INDIVIDUAL WHO IS LICENSED UNDER THIS PART.
- Enacting section 1. This amendatory act takes effect 90 days
