HOUSE BILL No. 4005

January 11, 2017, Introduced by Rep. Lucido and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

by amending sections 227 and 230 (MCL 750.227 and 750.230), section 227 as amended by 1986 PA 8; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 227. (1) A person shall not carry a dagger, dirk, stiletto, a double-edged nonfolding stabbing instrument of any length, or any other dangerous weapon, except a hunting knife adapted and carried as such, concealed on or about his or her person, or whether concealed or otherwise in any vehicle operated or occupied by the person, except in his or her dwelling house, place of business or on other land possessed by the person. THIS SUBSECTION DOES NOT APPLY TO EITHER OF THE FOLLOWING:
 - (A) A PERSON CARRYING A HUNTING KNIFE ADAPTED AND CARRIED AS A HUNTING KNIFE CONCEALED ON OR ABOUT HIS OR HER PERSON OR WHETHER

- 3 (B) A PERSON CARRYING A PISTOL CONCEALED ON OR ABOUT HIS OR

- 18 the maker, model, manufacturer's number, or other mark of identity
- 19 of a pistol or other firearm, shall be IS quilty of a felony τ
- 20 punishable by imprisonment for not more than 2 years or A fine of
- 21 not more than \$1,000.00. Possession of a firearm upon which the
- 22 number shall have HAS been altered, removed, or obliterated, other
- 23 than an antique firearm as defined by section $\frac{231a(2)}{a}$ or $\frac{b}{r}$
- 24 shall be 237A, IS presumptive evidence that the possessor has
- 25 altered, removed, or obliterated the same.
- 26 Enacting section 1. Section 231a of the Michigan penal code,
- 27 1931 PA 328, MCL 750.231a, is repealed.
