A bill to amend 1967 PA 281, entitled "Income tax act of 1967,"

(MCL 206.1 to 206.713) by adding section 277.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 277. (1) FOR TAX YEARS THAT BEGIN AFTER DECEMBER 31,
- 2 2017, A TAXPAYER WHO IS A QUALIFIED VOLUNTEER AND WHO PROVIDES
- 3 SAFETY AND SECURITY SERVICES IN A SCHOOL WITHOUT RECEIVING
- 4 COMPENSATION PURSUANT TO AN AGREEMENT ENTERED UNDER SECTION 1241 OF
- 5 THE REVISED SCHOOL CODE, 1976 PA 451, MCL 380.1241, MAY CLAIM A
- CREDIT AGAINST THE TAX IMPOSED BY THIS PART IN AN AMOUNT EQUAL TO
- 7 \$2.00 FOR EACH HOUR OR PART OF AN HOUR THAT THE QUALIFIED VOLUNTEER
- 8 PROVIDES SUCH SERVICES DURING THE TAX YEAR OR \$500.00, WHICHEVER IS
