## **HOUSE BILL No. 4145**

February 2, 2017, Introduced by Reps. Sheppard, Iden and Kosowski and referred to the Committee on Education Reform.

A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1241.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 1241. (1) THE BOARD OF A SCHOOL DISTRICT OR INTERMEDIATE

SCHOOL DISTRICT, BOARD OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY, OR
GOVERNING BODY OF A STATE APPROVED NONPUBLIC SCHOOL MAY ENTER INTO
AN AGREEMENT WITH A QUALIFIED VOLUNTEER TO PATROL SCHOOL PREMISES
FOR THE SOLE PURPOSE OF PREVENTING OR RESPONDING TO A MASS CASUALTY
EVENT CONNECTED WITH ILLEGAL ACTIVITY. TO IDENTIFY A QUALIFIED
VOLUNTEER, THE BOARD, BOARD OF DIRECTORS, OR GOVERNING BODY MAY
REQUEST A COPY OF THE LIST MAINTAINED BY THE MICHIGAN STATE POLICE
UNDER SECTION 15A OF 1935 PA 59, MCL 28.15A. IF THE QUALIFIED

- 1 VOLUNTEER IS CURRENTLY EMPLOYED AS A LAW ENFORCEMENT OFFICER, THE

- 20 UNDER THIS SECTION UNLESS THE INJURY, DEATH, OR LOSS RESULTED FROM
- 21 THE QUALIFIED VOLUNTEER'S RECKLESS OR WANTON CONDUCT.
- 22 (3) AS USED IN THIS SECTION, "QUALIFIED VOLUNTEER" MEANS AN
- 23 INDIVIDUAL WHO IS ON THE LIST MAINTAINED BY THE MICHIGAN STATE
- 24 POLICE UNDER SECTION 15A OF 1935 PA 59, MCL 28.15A.
- 25 Enacting section 1. This amendatory act takes effect 90 days
- 26 after the date it is enacted into law.
- 27 Enacting section 2. This amendatory act does not take effect
