A bill to amend 1976 PA 451, entitled
"The revised school code,"

(MCL 380.1 to 380.1852) by adding sections 1278e and 1278f.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1278E. (1) BY ENACTING THIS SECTION, THIS STATE
- 2 TERMINATES ALL PLANS, PROGRAMS, ACTIVITIES, EFFORTS, AND
- 3 EXPENDITURES RELATING TO THE IMPLEMENTATION OF MICHIGAN K-12
- 4 SCIENCE STANDARDS AND THE EDUCATIONAL INITIATIVE COMMONLY REFERRED
- 5 TO AS THE COMMON CORE STANDARDS, OR ANY DERIVATIVE OR PERMUTATION
- 6 OF THAT EDUCATIONAL INITIATIVE INCLUDING, BUT NOT LIMITED TO, THE
- 7 MICHIGAN COLLEGE AND CAREER READY STANDARDS THAT HAVE BEEN ADOPTED
- 8 BY THE LEGISLATURE, THE STATE BOARD, OR THE DEPARTMENT AND
- 9 INCLUDING, BUT NOT LIMITED TO, ANY ASSESSMENTS, DATA COLLECTION,
- 10 AND INSTRUCTIONS BASED ON OR INVOLVING THAT EDUCATIONAL INITIATIVE.
- 11 TO FURTHER PROTECT STATE AND LOCAL CONTROL OF PUBLIC EDUCATION, THE

- 1 STATE BOARD AND THE DEPARTMENT ARE PROHIBITED FROM ADOPTING,
- 2 ALIGNING TO, OR IMPLEMENTING ANY OTHER NATIONAL OR MULTISTATE
- 3 CONSORTIUM STANDARDS FROM ANY SOURCE OR REQUIRING THE USE OF ANY
- 4 ASSESSMENTS ALIGNED WITH ANY OTHER NATIONAL OR MULTISTATE
- 5 CONSORTIUM STANDARDS FROM ANY SOURCE, AND, SUBJECT TO SECTION
- 6 1278F, THE STATE BOARD AND THE DEPARTMENT SHALL DO ALL OF THE
- 7 FOLLOWING:
- 8 (A) RESPECT AND SUPPORT THE ULTIMATE RIGHT OF A PARENT TO OPT
- 9 HIS OR HER CHILD OUT OF PUBLIC SCHOOL, AND OUT OF ANY PUBLIC SCHOOL
- 10 ACTIVITY, PRACTICE, OR TESTING THAT THE PARENT FINDS UNACCEPTABLE,
- 11 WITH NO NEGATIVE REPERCUSSIONS TO, OR FINANCIAL IMPACT ON, THE
- 12 CHILD, PARENT, OR SCHOOL AND WITH NO INTERFERENCE FROM THIS STATE.
- 13 THIS SUBDIVISION DOES NOT PROHIBIT THIS STATE FROM FUNDING PUBLIC
- 14 EDUCATION ON A PER-PUPIL BASIS.
- 15 (B) BEGINNING WITH THE 2017-2018 SCHOOL YEAR, IMPLEMENT STATE
- 16 ACADEMIC CONTENT STANDARDS FOR EACH OF GRADES KINDERGARTEN TO 12 IN
- 17 ENGLISH LANGUAGE ARTS, MATHEMATICS, SCIENCE, AND SOCIAL STUDIES.
- 18 THE STATE ACADEMIC CONTENT STANDARDS SHALL BE THE SAME AS THE
- 19 ACADEMIC STANDARDS IN EFFECT IN MASSACHUSETTS DURING THE 2008-2009
- 20 SCHOOL YEAR, EXCEPT THAT ANY REFERENCE IN THOSE STANDARDS TO
- 21 "MASSACHUSETTS" SHALL BE CHANGED IN ALL APPROPRIATE INSTANCES TO A
- 22 REFERENCE TO "MICHIGAN" AND ANY STATE HISTORY OR GOVERNMENT CONTENT
- 23 STANDARDS SHALL BE CHANGED TO REFLECT THE HISTORY AND GOVERNMENT OF
- 24 THIS STATE. WITHIN 10 DAYS AFTER THE STATE ACADEMIC CONTENT
- 25 STANDARDS ARE IMPLEMENTED, THE DEPARTMENT SHALL DISTRIBUTE THE
- 26 STANDARDS TO ALL PUBLIC SCHOOLS IN THIS STATE AND MAKE THE
- 27 STANDARDS AVAILABLE TO THE PUBLIC ON THE DEPARTMENT WEBSITE.

- 1 (C) THE SUPERINTENDENT OF PUBLIC INSTRUCTION, THE STATE BOARD,
- 2 THE DEPARTMENT, OR ANY OTHER STATE PUBLIC EMPLOYEE OR AUTHORITY
- 3 SHALL NOT ADOPT OR IMPLEMENT ANY NATIONAL OR MULTISTATE CONSORTIUM
- 4 STANDARD FROM ANY SOURCE, OR THE USE OF ANY ASSESSMENTS ALIGNED
- 5 WITH A NATIONAL OR MULTISTATE CONSORTIUM STANDARD, THAT CEDES
- 6 CONTROL OF MICHIGAN EDUCATIONAL STANDARDS IN ANY MANNER, INCLUDING,
- 7 BUT NOT LIMITED TO, MATHEMATICS STANDARDS, ENGLISH LANGUAGE ARTS
- 8 STANDARDS, THE NEXT GENERATION SCIENCE STANDARDS, HISTORY
- 9 STANDARDS, SOCIAL STUDIES STANDARDS, OR SEX EDUCATION STANDARDS.
- 10 THIS STATE SHALL RETAIN SOLE CONTROL OVER THE DEVELOPMENT,
- 11 ESTABLISHMENT, AND REVISION OF COURSE OF STUDY STANDARDS FOR GRADES
- 12 K TO 12. THE SUPERINTENDENT OF PUBLIC INSTRUCTION, THE STATE BOARD,
- 13 THE DEPARTMENT, OR ANY OTHER STATE PUBLIC EMPLOYEE OR AUTHORITY
- 14 SHALL NOT JOIN ANY CONSORTIUM OR ANY OTHER ORGANIZATION IF
- 15 PARTICIPATION IN THAT CONSORTIUM OR ORGANIZATION WOULD CEDE ANY
- 16 MEASURE OF CONTROL OVER ANY ASPECT OF MICHIGAN PUBLIC EDUCATION TO
- 17 THAT CONSORTIUM OR ORGANIZATION.
- 18 (2) THE BOARD OF EACH SCHOOL DISTRICT AND BOARD OF DIRECTORS
- 19 OF EACH PUBLIC SCHOOL ACADEMY, CONSIDERING THE ACADEMIC CONTENT
- 20 STANDARDS IMPLEMENTED UNDER THIS SECTION, SHALL DO ALL OF THE
- 21 FOLLOWING:
- 22 (A) ESTABLISH A FUNDAMENTAL ACADEMIC CURRICULUM FOR ITS PUPILS
- 23 AT THE ELEMENTARY, MIDDLE, AND SECONDARY SCHOOL LEVELS. THE
- 24 FUNDAMENTAL ACADEMIC CURRICULUM SHALL DEFINE ACADEMIC OBJECTIVES TO
- 25 BE ACHIEVED BY ALL PUPILS AND SHALL BE BASED UPON THE SCHOOL
- 26 DISTRICT'S EDUCATIONAL MISSION, LONG-RANGE PUPIL GOALS, AND PUPIL
- 27 PERFORMANCE OBJECTIVES. THE FUNDAMENTAL ACADEMIC CURRICULUM MAY

- 1 VARY FROM THE STATE ACADEMIC CONTENT STANDARDS IMPLEMENTED UNDER
- 2 THIS SECTION.
- 3 (B) AFTER CONSULTING WITH TEACHERS AND SCHOOL BUILDING
- 4 ADMINISTRATORS, DETERMINE THE ALIGNED INSTRUCTIONAL PROGRAM FOR
- 5 DELIVERING THE SCHOOL DISTRICT'S OR PUBLIC SCHOOL ACADEMY'S
- 6 FUNDAMENTAL ACADEMIC CURRICULUM AND IDENTIFY THE COURSES AND
- 7 PROGRAMS IN WHICH THE FUNDAMENTAL ACADEMIC CURRICULUM WILL BE
- 8 TAUGHT.
- 9 (C) PROVIDE ADEQUATE TIME AND TRANSPARENCY FOR PUBLIC REVIEW
- 10 AND COMMENT ON THE ALIGNED INSTRUCTIONAL PROGRAMS BY ALL INTERESTED
- 11 MEMBERS OF THE COMMUNITY BEFORE FINAL IMPLEMENTATION.
- 12 (3) THIS SECTION SHALL NOT BE CONSTRUED TO PROMOTE ANY
- 13 RELIGIOUS OR NONRELIGIOUS DOCTRINE, PROMOTE DISCRIMINATION FOR OR
- 14 AGAINST A PARTICULAR SET OF RELIGIOUS BELIEFS OR NONBELIEFS, OR
- 15 PROMOTE DISCRIMINATION FOR OR AGAINST RELIGION OR NONRELIGION.
- 16 (4) THIS SECTION DOES NOT REQUIRE ANY SCHOOL DISTRICT OR
- 17 PUBLIC SCHOOL ACADEMY TO UTILIZE ALL OR ANY PART OF THE ACADEMIC
- 18 CONTENT STANDARDS IMPLEMENTED UNDER THIS SECTION. THE STATE BOARD
- 19 AND THE DEPARTMENT SHALL NOT IMPOSE ANY FINANCIAL CONSEQUENCE ON A
- 20 SCHOOL DISTRICT OR PUBLIC SCHOOL ACADEMY THAT IMPLEMENTS ACADEMIC
- 21 CONTENT STANDARDS DIFFERING FROM THOSE IMPLEMENTED BY THIS STATE
- 22 UNDER THIS SECTION.
- 23 SEC. 1278F. (1) THE DEPARTMENT SHALL IMPLEMENT VALIDATED STATE
- 24 ASSESSMENTS OF PUPIL ACHIEVEMENT USING THE ASSESSMENT USED IN
- 25 MASSACHUSETTS DURING THE 2008-2009 SCHOOL YEAR AND ALIGNED TO THE
- 26 ACADEMIC STANDARDS IN EFFECT IN MASSACHUSETTS DURING THE 2008-2009
- 27 SCHOOL YEAR. THESE ASSESSMENTS SHALL BE READY FOR USE BY THE FIRST

- 1 SPRING AFTER NEW STATEWIDE ACADEMIC CONTENT STANDARDS ARE
- 2 IMPLEMENTED UNDER SECTION 1278E(1)(B). THE DEPARTMENT SHALL NOT
- 3 REVISE THE ASSESSMENTS UNDER THIS SUBSECTION AGAIN FOR A PERIOD OF
- 4 AT LEAST 5 YEARS. THE NEW ASSESSMENTS IMPLEMENTED UNDER THIS
- 5 SUBSECTION AND ALL FUTURE ASSESSMENTS IMPLEMENTED BY THE DEPARTMENT
- 6 SHALL MEET ALL OF THE FOLLOWING:
- 7 (A) SHALL NOT REQUIRE, BUT MAY USE, COMPUTER TECHNOLOGY.
- 8 (B) EACH YEAR, WITHIN 30 DAYS AFTER THE ASSESSMENT IS
- 9 ADMINISTERED, SHALL BE AVAILABLE ON THE DEPARTMENT WEBSITE FOR ALL
- 10 SCHOOL ADMINISTRATORS, TEACHERS, AND PARENTS TO REVIEW.
- 11 (C) SHALL NOT COLLECT ANY OF THE FOLLOWING:
- 12 (i) DATA ABOUT THE VALUES, ATTITUDES, BELIEFS, AND PERSONALITY
- 13 TRAITS OF A PUPIL OR A PUPIL'S FAMILY.
- 14 (ii) MEDICAL, BEHAVIORAL, MENTAL, BIOMETRIC, OR PSYCHOMETRIC
- 15 DATA OF A PUPIL OR A PUPIL'S FAMILY.
- 16 (2) THE DEPARTMENT SHALL NOT IMPLEMENT AN ASSESSMENT DEVELOPED
- 17 UNDER THIS SECTION UNTIL THE PROPOSED ASSESSMENT IS APPROVED BY
- 18 BOTH HOUSES OF THE LEGISLATURE BY CONCURRENT RESOLUTION. THE
- 19 STANDING COMMITTEE HAVING JURISDICTION OVER EDUCATION LEGISLATION
- 20 IN EACH HOUSE SHALL CONDUCT AT LEAST 1 PUBLIC HEARING ON THE
- 21 PROPOSED ASSESSMENT AND SHALL POST NOTICE OF EACH PUBLIC HEARING AT
- 22 LEAST 2 WEEKS BEFORE HOLDING THE PUBLIC HEARING.
