A bill to amend 2011 PA 256, entitled

"Michigan fireworks safety act,"

by amending section 7 (MCL 28.457), as amended by 2013 PA 65, and by adding section 7a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 7. (1) Except as provided in this act, a local unit of
- 2 government shall not enact or enforce an ordinance, code, or
- 3 regulation pertaining to or in any manner regulating the sale,
- 4 display, storage, transportation, or distribution of fireworks
- 5 regulated under this act. HOWEVER, A LOCAL UNIT OF GOVERNMENT MAY
- 6 ENACT AND ENFORCE A GENERAL ORDINANCE, CODE, OR REGULATION THAT
- 7 DOES NOT APPLY SPECIFICALLY TO THE SALE, DISPLAY, STORAGE,
- 8 TRANSPORTATION, OR DISTRIBUTION OF FIREWORKS REGULATED UNDER THIS
 - ACT, BUT RATHER APPLIES GENERALLY TO THE SALE, DISPLAY, STORAGE,

- 1 TRANSPORTATION, OR DISTRIBUTION OF ALL GOODS.
- 2 (2) A local unit of government may enact an ordinance
- 3 regulating the ignition, discharge, and use of consumer fireworks,
- 4 including, but not limited to, an ordinance prescribing the hours
- 5 of the day or night during which a person may ignite, discharge, or
- 6 use consumer fireworks. If a local unit of government enacts an

- 1 ALL NECESSARY RESTRICTIONS AND REQUIREMENTS TO PROTECT PERSONS OR
- 2 PROPERTY IF THE STATE FIRE MARSHAL, THE COMMANDING OFFICER OF THE
