February 15, 2017, Introduced by Rep. Afendoulis and referred to the Committee on Appropriations.

A bill to amend 1979 PA 94, entitled "The state school aid act of 1979," by amending sections 201 and 201a (MCL 388.1801 and 388.1801a), as amended by 2016 PA 249.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

8 Sec. 201a. It is the intent of the legislature to provide
9 appropriations for the fiscal year ending on September 30, ~~2018~~
10 **2019** for the items listed in section 201. The fiscal year ~~2017-2018~~
11 **2018-2019** appropriations are anticipated to be the same as those
12 for fiscal year ~~2016-2017, 2017-2018~~, except that the amounts will
13 be adjusted for changes in retirement costs, caseload and related
14 costs, federal fund match rates, economic factors, and available
15 revenue. These adjustments will be determined after the January
16 ~~2017-2018~~ consensus revenue estimating conference.
