A bill to amend 1980 PA 299, entitled "Occupational code,"

(MCL 339.101 to 339.2677) by adding section 1439.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1439. A LICENSEE THAT EMPLOYS OR ENGAGES AN INDIVIDUAL TO
 2 PROVIDE SERVICES AS A SECURITY GUARD DIRECTLY TO THE LICENSEE'S
 3 CUSTOMERS SHALL ENSURE THAT ALL OF THE FOLLOWING ARE MET:
 - (A) BEFORE HE OR SHE ACTS AS A SECURITY GUARD WITHOUT DIRECT SUPERVISION, THE INDIVIDUAL COMPLETES AT LEAST 12 HOURS OF ON-THE-JOB, SITE-SPECIFIC TRAINING UNDER THE IMMEDIATE SUPERVISION OF AN EXPERIENCED SUPERVISOR.
 - (B) IN THE FIRST 90 DAYS OF HIS OR HER EMPLOYMENT, THE INDIVIDUAL COMPLETES AT LEAST 12 HOURS OF CLASSROOM TRAINING, SELECTED BY THE LICENSEE, THAT MEETS THE REQUIREMENTS OF SECTION 1440(1).
