

HOUSE BILL No. 4301

March 2, 2017, Introduced by Reps. Iden and Kesto and referred to the Committee on Oversight.

A bill to amend 2016 PA 370, entitled
"Electronic open access to government act,"
by amending section 1 (MCL 15.451).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1. (1) This act shall be known and may be cited as the
2 "electronic open access to government act".

3 (2) By January 1, 2018, the department of technology,
4 management, and budget shall include links on this state's website
5 to function, ~~and~~ contact, **AND EMPLOYEE SALARY** information for each
6 executive branch department and each major division or subunit
7 within the department. The information ~~shall~~ **MUST** be accessible to
8 the public at no cost. Each page created or maintained under this
9 section ~~shall~~ **MUST** meet all of the following criteria:

10 (a) Provide for uniformity and standardization of information

1 across departments.

2 (b) Use methods that are intuitive for searching, navigating,
3 and accessing information.

4 (c) Be designed to serve the purpose of facilitating public
5 access to government services.

6 (3) The information required under this act includes all of
7 the following for each department:

8 (a) A description of the primary functions of the department
9 and the telephone number and electronic mail address for the public
10 to contact the department.

11 (b) A description of the primary functions of each major
12 division or subunit of the department and the telephone number and
13 electronic mail address for the public to contact the division or
14 subunit.

15 (c) A graphical organization chart that includes the major
16 divisions or subunits of the department and the name, position
17 title, classified or nonclassified civil service distinction, and
18 contact information for the supervisor of each major division or
19 subunit. The chart must indicate the reporting relationship of the
20 supervisors.

21 **(D) A LIST OF THE DEPARTMENT'S EMPLOYEES THAT INCLUDES THE**
22 **NAME, POSITION TITLE, CLASSIFIED OR NONCLASSIFIED CIVIL SERVICE**
23 **DISTINCTION, AND SALARY FOR EACH EMPLOYEE. A DEPARTMENT SHALL NOT**
24 **PROVIDE THE INFORMATION REQUIRED UNDER THIS SUBDIVISION TO THE**
25 **DEPARTMENT OF TECHNOLOGY, MANAGEMENT, AND BUDGET IF DOING SO WOULD**
26 **ENDANGER THE HEALTH OR SAFETY OF THE EMPLOYEE.**

27 (4) Each department shall cooperate with the department of

1 technology, management, and budget in collecting and posting the
2 information required under this act. The department of technology,
3 management, and budget shall develop guidelines for the format and
4 display of the charts and other information to ensure the greatest
5 possible standardization. The department of technology, management,
6 and budget shall provide technical services and assistance to the
7 departments, as necessary, to create websites, coordinate links,
8 and maintain electronic connections necessary to implement this
9 act.

10 (5) Each department shall provide quarterly updates to the
11 information required under ~~this act.~~ **SUBSECTION (3) (A) , (B) , AND (C)**
12 **AND MONTHLY UPDATES TO THE INFORMATION REQUIRED UNDER SUBSECTION**
13 **(3) (D) .**

14 Enacting section 1. This amendatory act takes effect 90 days
15 after the date it is enacted into law.
